Re: Bost v. Illinois State Board of Elections, No. 24-568

Dear Mr. Harris:

I represent respondents the Illinois State Board of Elections and Bernadette Matthews, in her official capacity as the Executive Director of the Illinois State Board of Elections, in the above-captioned matter. On January 2, 2025, the Court directed respondents to file a response to the petition for a writ of certiorari, and our response is due, after two extensions, on Friday, April 4, 2025. Pursuant to Supreme Court Rule 30.4, we respectfully request a 10-day extension of time, to April 14, 2025, to file our response. Counsel for petitioners has authorized us to state that they do not oppose this request.

An extension is warranted for multiple reasons. Deputy Solicitor General Alex Hemmer, who is assigned to draft the brief in opposition for respondents under my supervision, has prior deadlines in other courts over the timeframe relevant to this request. These include a response to a motion for a stay pending appeal in *New York v. Trump*, No. 25-1236 (1st Cir.), filed on March 17, 2025; an amicus brief in *Wilcox v. Trump*, No. 25-5057 (D.C. Cir.), due on April 9, 2025; and an amicus brief in *Welty v. Dunaway*, No. 24-4968 (6th Cir.), due on April 10, 2025. My work responsibilities also warrant an extension of time: As Illinois Solicitor General, I devote substantial time to performing supervisory and administrative duties, including editing briefs in other cases and helping prepare attorneys for oral argument.
