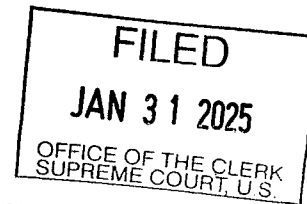

REASONS FOR GRANTING THE PETITION


MY First Amend. Right was Violated
