Request for Extension of Time to File Brief in Opposition

Dear Mr. Harris:

Respondents, Joshua A. Gallardo, Robert Travis Babcock, and Young County, Texas (“Respondents”), through their undersigned counsel, respectfully request a 30-day extension of time to respond to Petitioners’ Petition for a Writ of Certiorari (the “Petition”), pursuant to Rule 30.4.

Petitioners filed their Petition on March 10, 2025, and Respondents filed their Waiver of Right to Respond on March 20, 2025. Respondents subsequently received the Court’s Notice dated March 27, 2025, requesting that Respondents file a Response to the Petition on or before April 28, 2025.

4. *Hightower, et al. v. RE/MAX Homeland Realty, Inc., et al.*, No. 118430-489 (489<sup>th</sup> District Ct.). Respondents' Counsel is finalizing a Motion for Summary Judgment.
  5. Respondents' Counsel is preparing litigation on behalf of an Illinois underage football player involving name, image, and likeness (NIL) payments.

Respondents require an extension of time to sufficiently address the issues relevant to the Court's decision to grant or deny the Petition. Respondents, therefore, respectfully request a 30-day extension of time, up to and including May 28, 2025, within which to file their Brief in Opposition to the Petition.
