Reason for Request for an Extension:

I plan to bring forth in my Petition for a Writ of Certiorari the manner in which I was denied proper access to the Pennsylvania Court system, where none of my correctly prepared and presented court filings were presented for judicial consideration. It started in the trial court, continued in the intermediate appellate court, and then through the Supreme Court of Pennsylvania, up through and including the denial of my Application for Reconsideration on February 5, 2025.

A week after my June 10, 2024 filing for Petition for Allowance of Appeal in the Supreme Court of Pennsylvania, the whole process started all over again at the North Huntingdon township level with the filing by the township solicitor and the zoning officer of multiple summary offenses filed at the local magistrate. I appealed the magistrate so—called guilty verdicts to the trial court of Westmoreland County. "So-called" because when I went to the trial on March 25, 2025 the six original citations were nowhere in sight. The whole trial was held without them. According to the docket sheets to this day in the Pennsylvania's Unified Judicial System, the original magistrate papers are still being waited on by the trial court; yet the magistrate docket sheets indicate that they were sent shortly after I filed my appeal in the trial court.

Furthermore, The United Judicial System docket sheets are being manipulated on a regular basis, and the very system has been tampered with so that the "time filed" doesn't print on the docket sheet, only the date. This is only for

my cases as docketed in the trial court, however; the docket sheets for the cases as they appeared at the magistrate level show both the date and time that the docket sheets are being printed. Moreover, the trial court docket sheets have been/are being manipulated such that there is an interference with my rights to even file an appeal to the superior court. This is the case since the hard copies of the guilty verdicts signed by the judge were signed dated March 25, 2025. Yet there is no date of actual entry of the orders on the docket sheets, which date would determine my 30-day deadline to appeal. Instead, the docket sheets read (as of this particular moment), that the guilty verdicts were entered on March 26, and were e-filed to the township solicitor who prosecuted the case in the trial court. There is no indication that I, as the defendant, even got notice, and they are not even proper entries in the docket sheets that show the date of entry of the trial judge's orders. Moreover, the docket sheets mark the cases as closed and they indicate that the township solicitor who prosecuted the cases, represents me, as the defendant. It is quite bizarre, even more so than the first time around.

As this situation, which goes directly to the questions I plan to raise in my Petition, *is ongoing*, I feel that my filing of the petition by May 6, 2025, would be premature. That is, I need the additional 60 days, to perfect my Petition for Writ of Certiorari, to encompass this current situation.

Therefore, I respectfully request a gracious 60-day extension from May 6, 2025, the date my Petition would otherwise be due in this Court.
