- I, Andrea Nicole Weetly, declare under penalty of perjury under the laws of the United States that the following is true and correct: (Please see attached exhibits.)
  - 1. I am the Petitioner in this case. I am a domestic violence survivor currently experiencing homelessness while raising my son. I am submitting this declaration in support of my application for a 30-day extension of time to file my Petition for Writ of Certiorari.
  - 2. I have faced extraordinary hardships throughout this litigation. In 2021, I was under medical care for trauma-related symptoms, including anxiety, insomnia, and depression, as a result of an emotionally and financially abusive relationship. I have attached doctor's notes from 2021 as Exhibit A to confirm this. I have since lost access to medical care due to financial hardship.
  - 3. I am currently on public assistance and do not have access to disposable income, a printer, or reliable transportation. These limitations have severely impacted my ability to prepare my Supreme Court petition and mail documents on time.
  - 4. My vehicle was repossessed in October 2024. I have no permanent housing. My child and I were first made homeless in 2023 after being ordered to vacate the family home and evicted again in 2025 due to the ongoing financial harm caused by the court's refusal to release funds to which I am legally entitled.
  - 5. From December 2023, Respondent's counsel—who was appointed as receiver of the home proceeds trust without my consent—refused to send me my home proceeds ordered by the court. He continues to withhold the latest \$70,000 distribution granted by the court and has demanded I retrieve them from his office, knowing that I do not have transportation. I requested that the court appoint a neutral receiver, but that request was denied. As a result, I remain without access to my property and unable to fund basic needs or legal assistance.
  - 6. On the day before this petition was due, I saw Respondent's counsel served me with another round of filings in our ongoing state litigation, which required immediate attention. If I did not respond, it could have affected my ability to prove contempt of court, further harming my case. Because of this, I was forced to prioritize urgent local filings over preparing and mailing the writ.
  - 7. I have filed multiple requests for a stay to allow time to prepare this appeal, all of which were denied. I have been left to navigate more than 25 court hearings without an attorney. I previously had a limited-scope attorney for five months, but could not continue to retain because I was denied access to my sole retirement assets and attorney's fees—even though the court found Respondent had the ability to pay.
  - 8. Additionally, while the court issued a **minute order** reflecting a \$70,000 distribution to Petitioner on 3/27/25, **no formal, signed order was issued**. This has prevented Petitioner from enforcing the distribution or appealing unresolved financial matters. Since 2021, Petitioner has repeatedly faced this form of procedural obstruction, where court actions are announced in hearings or minute entries but never reduced to enforceable written orders. Without a signed order, Petitioner's constitutional rights to due process and appeal are functionally denied. This ongoing refusal to formalize orders especially those involving financial relief has substantially delayed Petitioner's access to justice and further
