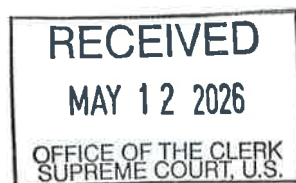
Dear Mr. Harris:

I am counsel of record for Respondents Mosaic Health, Inc. and Central Virginia Health Services, Inc. I write pursuant to Rule 30.4 to request a 30-day extension of time to file a brief in opposition to certiorari in case number 25-1070.

The petition for a writ of certiorari in the above-captioned case was filed on March 5, 2026, and this Court called for a response on April 30, 2026. Respondents' brief is currently due on June 1, 2026. The requested 30-day extension would move that date to July 1, 2026. This is Respondents' first request for an extension.

The requested extension is necessary to provide sufficient time to adequately address the issues raised by the Petition as well as due to pressing deadlines in other matters. An extension would also enable Respondents to review and respond to the amicus curiae briefs that were submitted on April 10, 2026 in support of the petition. 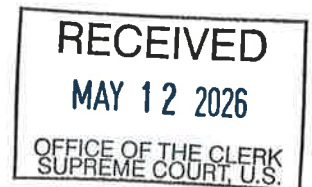
