Dear Mr. Harris:

The applications construed as petitions for writs of certiorari before judgment in the above-captioned cases were granted, and the cases consolidated, on March 16, 2026. The Court has ordered briefing on an expedited schedule, with the government's opening brief due on Monday, March 30, 2026.

Given the highly expedited timeframe and the amount of material the parties have designated, it would be very difficult to prepare and print the joint appendix in 6 $\frac{1}{8}$ -by-9 $\frac{1}{4}$ -inch booklet format before the brief is finalized. Accordingly, in lieu of a booklet-format joint appendix, the government respectfully request leave to provide the Court with the joint appendix in bound 8 $\frac{1}{2}$ -by-11-inch format.

Counsel for respondents have informed the government that respondents agree to this proposal.
