Respondents Cendyn Group, LLC is a private company owned by Cendyn Parent, Inc. Cendyn Parent, Inc. is 100% owned by Cendyn Group Holdings LLC, a portfolio company of Accel-KKR. No publicly held corporation holds 10% or more of Cendyn Group, LLC's stock.

Respondent The Rainmaker Group Unlimited, Inc. has no corporate parent, and no publicly held corporation holds 10% of any stock it might issue.

Respondent Caesars Entertainment, Inc. is a publicly traded company that has no parent corporation. BlackRock, Inc. is a publicly held company that is the beneficial owner of 10% or more of Caesars Entertainment, Inc.'s stock.

Respondent Treasure Island, LLC, is a private company in which the following entities have a direct pecuniary interest: Ruffin Acquisition, LLC, Phillip G. Ruffin Nevada Gaming Trust, and Phillip G. Ruffin.
