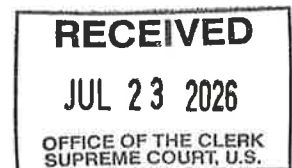

On behalf of Respondent financialright Claims GmbH, and pursuant to Rule 30.4, we respectfully request a 30-day extension of time to file a response to the petition for a writ of certiorari.
