**Certificate of Compliance**

1. I am over 18 years of age and am competent to testify. All statements herein are based on my personal knowledge.

2. My name is Sean Kuhlmeier. I am the Appellant *pro se* in the above captioned action seeking review before the United States Supreme Court. I provide this Certificate of Compliance in good faith compliance with USSCT Rule 33.1(h).

3. Per USSCT Rule 33.1(h) I prepared the included Petition for a Writ of Certiorari (Petition) in good faith compliance with this court's format rules.

4. The included Petition is formatted in Century Schoolbook font, 12 pt type. It is

1 spaced 1.15 which exceeds a 2-point lead between lines. Quotations in excess of 50 words are  
2 indented. Footnotes are 10 pt type, spaced 1.15 which exceeds a 2-point lead between lines, with  
a 2.5 pt lead both before and following the footnote paragraph. The document is double-sided.

3 5. The document is prepared on Hammermill Premium paper, 60lb, 100 Bright  
4 finish. The finished booklet size is 6 1/8" x 9 1/4", with a text field of 4" x 7", with 1" minimum  
margins on all sides. The cover is prepared on 65lb white cardstock.

5 6. The booklets are bound in perfect binding with glued edges, and a wrap around  
cover of the 65lb white cardstock.

6 7. I performed all the work on the document and booklets including authoring the  
legal argument, and printing, and binding the booklets.

7 8. The filing fee of \$300 is enclosed.

8 9. Per Rule 33.1(d) The document contains 8,908 words, of a 9,000 word limit,  
9 which does not include the pages containing the questions presented, the list of parties and  
corporate affiliates of the filing party, the table of contents, the table of cited authorities, the  
listing of counsel at the end of the document, or any appendix.

10 10. Per USSCR Rule 33.1(f), Forty copies of the document in booklet-format, and  
11 one unbound copy of the document on 8 1/2- by 11-inch paper are submitted. I am willing to  
provide an electronic copy if requested.

12 11. Additional copies are being served on counsel for the opposing party, and the  
Washington State Attorney General.
