Dear Mr. Harris:

I represent Respondent the Coalition of Abused Scouts for Justice. I write to alert the Court to a development in this case that may be relevant to any further proceedings before this Court. In the Coalition's brief in opposition, the Coalition emphasized the need for a quick resolution of the petition for a writ of certiorari to allow the survivors of this horrific abuse to obtain closure and compensation. The Coalition noted that most of the proceeds (approximately \$1.4 billion) contributed to the compensation trust for survivors were being held in escrow until final resolution of this case. We explained our understanding that "those remaining proceeds, plus interest, would be released into the trust within days of this Court's denial of certiorari." Br. in Opp. 10.

Since this Court's denial of certiorari, however, the insurers that contributed those funds have taken the position that the escrow cannot be released until the deadline for seeking rehearing of this Court's certiorari denial has passed or until this Court denies a timely petition for rehearing. The deadline for seeking rehearing is tomorrow, February 6, 2026. *See* S. Ct. R. 44.2. The Coalition respectfully asks the Court to accept this clarification of the Coalition's previous statement and notice this subsequent development in the Court's consideration of any forthcoming rehearing petition.
