# AMENDED MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

Reynaldo Alberto Peña, the Petitioner herein, Files this Amended Motion to the Supreme Court of the United States, to permit him to file and proceed on this Petition for Writ of Certiorari in forma pauperis. Counsel for the Petitioner has been appointed, under the provisions of the Texas Code of Criminal Procedure (specifically,

Tex. Code Crim.Pro. art. 26.044 and Tex. Code Crim. Pro. art. 26.04 *et. seq.*) in the trial court, the 229<sup>TH</sup> District Court of Duval County, Texas. The Orders of the Court are attached as *appx*. A and *appx*. B. Additionally, the Declaration of Counsel regarding the *in forma pauperis* history of Petitioner is attached as *appx*. C.

The Petitioner's appointed attorney, Abner Burnett, is a solo practitioner. This is the first case he has brought to the United States Supreme Court. The Court admitted him to practice before the Court the day before yesterday. He called the Court Clerk and learned of this yesterday. The deadline to file a petition for Writ of Certiorari was yesterday. Mr. Burnett's eFile account will not activate until tomorrow.

No local print shop or office supply could get the copies of the Petition ready in time to file an original and ten copies yesterday. In the fury to get at least the original on file in a timely manner, Mr Burnett inadvertently failed to include the exhibits with his original Motion. They are included with this Amended Motion. The copy of the first Order appointing is a poor one. However, the public defender organization that the Trial Court originally appointed no longer exists.

The copy included with this Motion is the best copy that the Trial Court clerk could provide. The second Order is current. Mr. Peña has been recognized by the Trial Court as qualified to receive an appointed attorney since the beginning of his case.

# **Prayer for Relief Requested**

Wherefore Premises Considered, Petitioner, Reynaldo Alberto Peña, respectfully prays this Court GRANT this motion and allow the Petitioner, Reynaldo Alberto Peña, to proceed on this case in forma pauperis and without being required to prepay fees and costs and file 40 copies of this petition in booklet form.


