Subsequent to finding Whiteside, who was found to be driving through parking lots used by the Carteside to park he hicle, Whiteside was taken into custody for stalking and the vehicle he was driving (2018 Chevrolet Impala) was impounded. During impoundment, a cursory inventory search was conducted under low light inditions. I initially aided in this cursory inventory and located two collapsible batons (similar to what police carry) well as two cellular phones. I had the vehicle subsequently transported to the UMPD Sally port area so a search arrant could be obtained and a better search made.						
M. From interviewing C told me that Whiteside is the owner of a laptop computer. C that she has seen the laptop computer at Whiteside's residence and also seen Whiteside in possession of it we hospital when he has sought treatment. C described this laptop computer as black in color but did not make or model of it.						
N. Calculate also informed me that during her contact with Whiteside on 02/08/2022 he displayed on his cellular photograph multiple sexually explicit photographs of her. Calculate informed me that it appeared as if there were more photograph of her that what she previously recalled being taken and previously had been deleted. Calculate indicated that Whiteshas retained these images without her permission and suspects that other images of her may have been taken of which she is unaware of.

I know from training and experience that a cell phone (such as Whiteside's) can be connected to a laptop computer and the images stored on the cell phone be placed on the laptop computer as a means to further store the images or to ake copies of the images (such as connecting the laptop to a printer or burning DVD's on the laptop). I also know om training and experience that people who stalk other people, often obtain and store images of them on multiple evices or multiple storage platforms to include tablet computers, thumb drives and external hard drives. I also know at those who stalk others sometimes use hidden cameras to obtain additional images or may print out additional mages to review for their own benefit.
