

MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

Petitioners respectfully move for leave to proceed in forma pauperis pursuant to Rule 39 of this Court. Petitioners have not previously sought leave to proceed in forma pauperis in the court below or any other court.

Petitioners are currently unemployed and without sufficient income or assets to pay the costs of printing and filing. Until May 2025, Petitioner Valeria Taveras was employed by the International Air Transport Association (IATA), where her position was eliminated following the closure of her department. Petitioners had relocated to Spain in 2018 in reliance on her employment but were compelled to return to the United States after her termination. 
