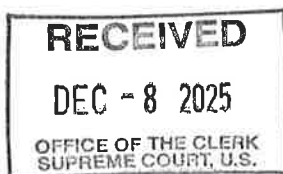

Petition for Reconsideration of The Denial of courts Ruling November 10, 2025

Concise, Briefly, and Distinctly Statements of the cause

(1). QUESTIONS PRESENTED PERTAINING TO LOWER FEDERAL COURT, APPEALS COURT'S CRITICAL ERRORS IN THEIR REFUSAL TO ADDRESS CONSTITUTIONAL PROVISIONS AND LAW PRINCIPLES PERTAINING TO PETITIONERS RIGHT TO TRAVEL FREELY

(2). We, all Petitioners, conditionally accept your offer as outlined in your letter dated November 24th 2025 signed by Scott S. Harris Clerk. and Angela Jimenez upon proof of claim that all Petitioners have not fully complied with rule 44 (and all other rules) as outline below. " The petition must briefly and distinctly state its grounds and must be accompanied by a certificate stating that the grounds are limited to the intervening circumstances of substantial or controlling effects or other substantial grounds not previously presented. See xv. Petition for Rehearing (Rule 44) that the word limits did not exceed 3,000.00 words, that all Petitioners have fully complied with, and

(3). Proof that all Respondents have not violated all Petitioners' God given rights and constitutional Fourth, Fifth, Sixth, Seventh, Eighth, Ninth, and Tenth Amendments and right to travel by converting Petitioners' right into a privilege to drive. Proof that this court has not caused a Manifest injustice which refers to a decision or outcome in a legal case that is clearly unfair, unreasonable, or erroneous to a degree that shocks the conscience and undermines the integrity of the judicial process, by the Denial of original Petition Ruling November 10, 2025, that has caused a manifest injustice because the court's decision was in

contradiction to all the evidence and facts presented in the original Petition by all Petitioners, and

(5). Proof that this court's rejection letter dated November 24, 2025, is not in direct violation of well-settled law listed below, and

(6). United States v. Will, 449 U. S. 200 "We have no more right to decline the exercise of jurisdiction which is given than to usurp that which is not given. The one or the other would be treason to the constitution. **Questions may occur which we would gladly avoid; but we cannot avoid them.**" and

(7). Cohens v. Virginia, 19 U. S. 6 Wheat. 264 264 (1821) "With whatever doubts, with whatever difficulties, a case may be attended, we must decide it if it be brought before us. RE: VIOLATION OF U.S. SUPREME COURT RULINGS REGARDING THE RIGHT TO TRAVEL

SUBJECT: EDUCATION OF LAW ENFORCEMENTS AND NORTH CAROLINA JUDICIARY

Dear Governor McCrory,

We are sending this correspondence to make you aware of the unconstitutional acts committed by your law enforcement agencies and state courts against the people of North Carolina. These acts may or may not have been committed knowingly or unintentionally but we are writing to your office to ensure that these violations are brought to your attention so that they can be addressed and corrected.

As you may or may not know, there are people in your state whose status is ostensibly different than the average US Citizen and are considered Foreign Nationals or American Nationals with certain safeguards and protection under the law. Our primary concern is that their travel rights in your state are not infringed.

In order to educate your law enforcement regarding Foreign Nationals or American Nationals in your state, you can call the Department of State here in Washington, D.C. to get clarity or you can go to the Department of State's website at _____ or our website at _____ and download the manual. The Department of State also offers training for your law enforcement officers free of charge to raise awareness and compliance. Log on to:


We have enclosed one of our affidavit forms for the exemption of registration and licensing for Foreign Nationals that Foreign Nationals have to file in your state to lawfully claim the exemption. This affidavit also can be used by U.S. Citizens who are not driving or operating a motor vehicle for profit or for hire.

Please forward this information to all of your law enforcement agencies in your state to prevent any unnecessary lawsuits from being filed against these agencies for not following the law and violating the rights of the people to freely travel without interference unless they are a threat to the public safety.

If you have any questions regarding this matter please feel free to respond in writing by mail or fax any questions or concerns you may have and we will be happy to answer and address them.

Thank you in advance for your cooperation and consideration in this matter.
