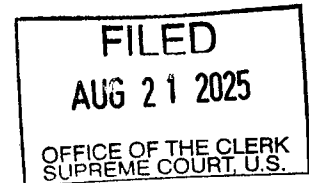

**AFFIDAVIT OR DECLARATION
