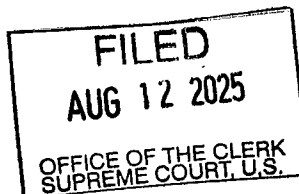

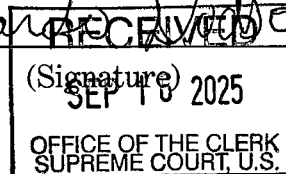

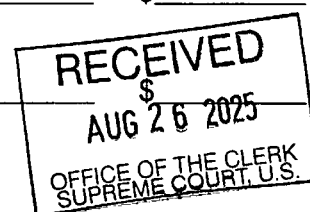


**AFFIDAVIT OR DECLARATION

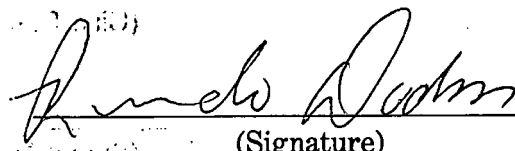
