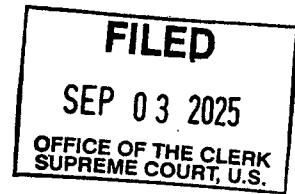

Defendant Farmer has filed four motions in the past month: a motion notifying the Court that the Clerk has denied him copies of the trial jury verdict forms and refused to provide a letter regarding whether a transcript exists of the fifth superseding indictment [DE 3423]; a "supplement" Federal Civil Procedure Rule 59 and 60 motion contesting this Court's denial of his motion filed under *Hazel-Atlas* [DE 3431]; a motion for the Court to take judicial notice under Federal Rule of Evidence 201(b) alleging prosecutorial misconduct [DE 3434]; and a motion for reconsideration of the denial of counsel [DE 3435].

As I have recapped before, Defendant Farmer is serving a term of life imprisonment for gang-related activities with the Latin Kings and the brutal murders of Marion Lowery and Harvey Siegers. He has already filed an unsuccessful appeal with the Seventh Circuit which affirmed his convictions and sentence [Case No. 20-3119], and Farmer filed a writ of certiorari with the United States Supreme Court which was denied on February 21, 2023. *United States v. Farmer*, No. 22-6597, 2023 WL 2124226

(Feb. 21, 2023). Farmer then filed numerous motions with this Court including a Motion under 28 U.S.C. § 2255, all of which I denied on May 23, 2024, and denied a certificate of appealability. [DE 3336.] Farmer then filed a notice of appeal from the orders relating to the denial of his section 2255 motion [Case No. 24-2002]. The Seventh Circuit found “no substantial showing of the denial of a constitutional right” and denied the appeal, the request for a certificate of appealability, and a request for rehearing. [Case No. 24-2002, DE 32, 45.]

As I reasoned in my order dated January 14, 2025, I lack jurisdiction over these collateral attacks on his sentence. [DE 3421.] As the Seventh Circuit recently recognized, “[o]nce a criminal case ends in a sentence, the district court’s jurisdiction lapses unless a rule or statute specifically authorizes the court to act . . . [o]therwise, a court does not have authority to entertain the motion and must dismiss it.” *United States v. King*, No. 24-2303, 2025 WL 40874, at \*1 (7th Cir. Jan. 7, 2025); *see also Hazel-Atlas Glass Co. v. Hartford-Empire Co.*, 322 U.S. 238 (1944). Because Farmer has not received permission for these successive collateral attacks on his sentence, these requests must be dismissed for lack of jurisdiction.

ACCORDINGLY:

The motions at DE 3423, DE 3431, and DE 3434 are DISMISSED for lack of jurisdiction.

The motion to reconsider the order denying appointment of counsel [DE 3435] is DENIED.
