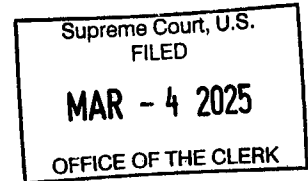

The appellant is unable to pay the costs of this case due to ongoing financial hardship. Unemployed since 2016 as a result of workplace retaliation and its aftermath, the appellant suffers from lasting health complications that require continuous treatment. She has no stable income, limited assets, and relies on public assistance for essential needs including housing and medical care. These conditions are the result of systemic harm—not temporary misfortune—and have caused long-term disability and economic instability. Given these circumstances, the appellant respectfully requests leave to proceed in forma pauperis.
