

On or around February 8 2022 I James Lee White stopped at the main Post Office at 15 and Marion to continue my held mail for another month . Which is a service of the Post Office . Given that I am the sole proprietor of Offering Help Co as a business I was allowed to hold my mail until I could afford a Po box because of my disability .I am on Social security and have cancer I told the clerk it would take me a couple months to afford the 100 plus dollars to rent a Po box It all arised from thefts of my mail .l headed to pickup my held mail at the United States Postal Service Capital Hill annex facility To see if I had mail When I arrive there were about three people waiting the young lady who also was a business owner received her mail and left when it was my turn a white young John Doe gave me a not so welcoming look vigorously shut the window and left for about five minutes without one word to me our any one else when he came back he was accompanied by a black Jane Doe Female who stated my mail had been delivered to my address and that I couldn't have mail held because I wasn't on vacation which isn't true .i had just left the post office and completed the application to hold my mail for thirty more days I ask for her supervisor and was told she was on vacation Why didnt' John Doe White tell me the same thing Jane Doe black told me Because they felt that because she was black it wouldn't be discrimination they were wrong in there assumption They made a plan to discriminate against me and they went through with their Plan I am ask the court to amend my claim to a Title 6 civil rights violation That is intentional discrimination and disparate impact . And entitles me to monetary relief I have never been so embarrassed and humiliated in my life. Every person waiting was shock and some tried to consul me that's how shocking the situation was. I am clearly stating a claim in these matter before you your honor.
