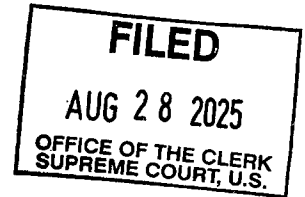

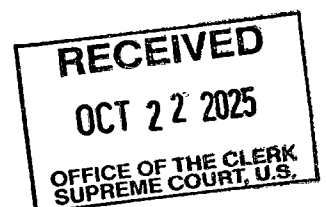


**MOTION FOR LEAVE TO PROCEED WITHOUT PREPAYING OF COSTS**
