

Samson Orusa has filed a Request for Sentence Reduction Due to Amendment 821 and Supreme Ct. Ruling in Paul Erlinger v. US (Doc. No. 407). Pursuant to Administrative Order 220, the Court requests the Federal Public Defender's Office to consult with Samson Orusa on his request. Within forty-five days, of Defendant's pro se pleading, selected counsel shall either file an appearance indicating that Defendant desires representation or file a notice that Defendant declined representation and is proceeding pro se.

Upon the filing by counsel of a claim for relief, or supplemental claim, the United States will have thirty (30) days to file a responsive pleading.
