THE COURT

The court has reviewed appellant's motion filed January 23, 2025, in this case, along with the opposition filed by respondent on January 27, 2025. In the motion, appellant asks this court to vacate two orders it made in 2022 as part of its review of appellant's related petition for writ of mandate, case No. E079226. This court denied that petition in an order dated July 22, 2022. First, appellant asks this court to set aside its order of July 12, 2022, waiving filing fees for the real party in interest in the mandate action. Second, appellant asks this court to vacate what appellant describes as an order dated July 22, 2022, "transferring the underlying family law case from California to Iowa, upon issuance of the remittitur in court of appeals case number E079240, which is still pending before this Court." In fact, the order of July 22, 2022, both denied appellant's petition in case No. E079226 and continued this court's previous stay of the superior court's transfer order until the remittitur issues in the current case, No. E079240. Because appellant provides no legal basis for granting this motion regarding a petition for writ of mandate that was denied more than two and one-half years ago, the motion is DENIED.

THE COURT

The court has reviewed appellant's motion filed March 3, 2025, to reconsider order filed February 19, 2025, denying motion to set aside orders waiving filing fees and transferring jurisdiction to Iowa along with respondent's opposition filed March 3, 2025. Appellant's motion is DENIED for the reasons stated in the order of February 19, 2025. The court notes that appellant still has cited to no legal authority requiring this court to undo the mandate proceedings concluded on July 22, 2022, based on appellant's assertions that this court should not have granted respondent a fee waiver during those proceedings. Respondent's request that this court deem appellant a vexatious litigant is DENIED without prejudice.
