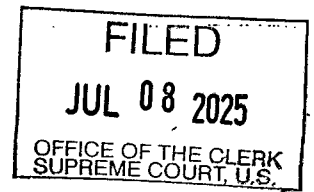

REASONS FOR GRANTING THE PETITION


Adults in Custody lives/Voice matters, too!
