MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

The petitioner asks leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*. Petitioner was declared indigent by the trial court below and was appointed counsel pursuant to Texas Code of Criminal Procedure article 26.052. Petitioner sought leave to proceed *in forma pauperis* in this Court on a Petition for a Writ of Certiorari to the Texas Court of Criminal Appeals from its decision affirming the portion of this judgment sentencing him to death. *See Tijerina Sandoval v. Texas*, No. 23-5618 (Sept. 14, 2023). The Court denied the petition and did not rule on the motion. *Id.* A declaration in support of this motion is attached.
