I affirm that I submitted my petition on time. I believe the delay in mailing and processing occurred because the prison was on 'lockdown' for more than three (3) weeks during that period.


I respectfully submit this declaration to clarify that any delay in the mailing process was not caused by me, but rather due to circumstances beyond my control within the institution.

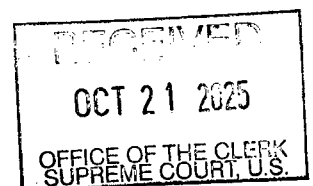
