I live in a tent on the street in Los Angeles, CA. I live alone. I am unemployed for more than 4 years. Due to the federal government shutdown, I did not receive food stamps for 11/2025. I do not know when I will receive food stamps. I receive \$221/month of welfare for basic needs. I am Jewish and religious. I keep Kosher and Jewish Sabbath. I am the sole trustee of Judaism for Humans Home Trust which owns .25 acres of vacant land in Etowah County, Alabama, assessed at a value of approximately \$6000, encumbered by municipal liens and unsaleable. By any calculation, my assets, including those of the trust, are less than the annual 2025 Federal Poverty Guidelines for the 48 contiguous states and Hawaii.
