Would it be possible to tell me which of the five factors I did not meet or is it possible to reconsider this denial decision.

I ask if you would speak to the FBI, specifically Chris Wray, for further information if needed, to reconsider the denial of my case.

Any clarity or assistance is very much appreciated.

I do realize that they are subject to their own justice system in the CIA but I can not get there yet. I will forward this email to the CIA OIG upon the completion of it.

I have a friend that goes to church with me, Liz Gilroy. Her name was said many times and last night for sure. She is from Santa Rosa. I will assist her as much as I can if she needs it, but she is elderly and may not be up to defending herself if she needs to. This is simply put insurance, if she needs it.

"Precisely fool" is DOJ and known to be involved in deep trouble. He may be the reason my mother has been involved in her own sufferings, just because she is my Mom. I am reporting him and if he is guilty of (other) crimes besides targeted harassment I wish to press full charges against him for targeting my Mom.

This morning "F*ck Mouth", FBI personnel made it very difficult to carry on with my morning, by targeting me in the Middle and using his phone to assist in this. I am reporting him. He is dangerous because of his abilities.

The DOJ has been quiet and I notice the difference. But the ring of 20 or so that are cop/DOJ continue in their bid to bring down the much work already established and keep complicating things, in the Middle certainly. ② Our specialists determine the next step

We may decide to:

Open an investigation or take some other action within the legal authority of the Justice Department.

Collect more information before we can look into your report.

Recommend another government agency that can properly look into your report. If so, we'll let you know.

In some cases, we may determine that we don't have legal authority to handle your report and will recommend that you seek help from a private lawyer or local legal aid organization.

③ When possible, we will follow up with you

We do our best to let you know about the outcome of our review. However, we may not always be able to provide you with updates because:

We're actively working on an investigation or case related to your report.

We're receiving and actively reviewing many requests at the same time.

If we are able to respond, we will contact you using the contact information you provided in this report.

Depending on the type of report, response times can vary. If you need to reach us about your report, please refer to your report number when contacting us. This is how we keep track of your submission.

What you can do next
