MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

The Petitioner, Steven Matthew Wolf, by and through undersigned counsel, respectfully moves this Court for leave to proceed *in forma pauperis* in the above-styled cause pursuant to Rule 39.1 of this Court. Mr. Wolf is petitioning for a writ of certiorari to review the decision of the Florida Supreme Court affirming his conviction and sentence of death. The Sixteenth Judicial Circuit of Florida found Mr. Wolf indigent. Accordingly, that court appointed the Office of the Public Defender to represent him on appeal pursuant to Sections 27.51 and 27.52, Florida Statutes. Pursuant to Supreme Court Rule 39.1, a copy of the lower court's order appointing counsel is appended to this motion.

WHEREFORE, Petitioner moves this Court to allow him to proceed *in forma pauperis* and file and prosecute his petition for writ of certiorari without paying fees or costs.


