

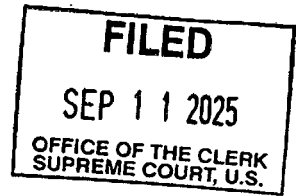

- Article III section 2: Judicial Powers shall extend to all cases, in Law and Equity, arising under this constitution, the Law of the United States, and the Treaties made, or which shall be made under their authority - to all cases affecting Ambassadors, or Public Ministers and Consuls - to all cases of admiralty and maritime Jurisdiction - to Controversies ~~between~~ ~~between two or more states~~ to which the United States be a Party - to Controversies between two or more states - between a state and citizens of another state - between citizens of different states - between citizens of the same state claiming lands Grants of different states, and between a state, or the citizens thereof, and foreign states citizens or subjects
- Section 3: Treason against the United States shall consist only in levying war against them - or in adhering to their enemies, giving them aid and comfort. No Person shall be convicted of Treason unless on the testimony of two witnesses to the same overt Act = (Not secret) or confession in open court
- Article IV - Section 1: Full faith and credit shall be given in each State to the Public Act Records, and Judicial Proceedings of every other State, and Congress may by general Laws prescribe the manner in which such Acts, Records and Proceedings shall be proved.
