Petitioner, Anthony Roland, respectfully moves this Honorable Court for leave to proceed in forma pauperis in connection with the filing of a petition for a writ of certiorari.

Application Financial Status

At the time of the lower-court lawsuit, I was working approximately 30 hrs. per week. Since then, my employer has reduced my schedule to 8-16 hrs. per week, which has significantly reduced my income. The reduction in my work hrs. and the combination of inflation have made it difficult for me to meet basic living needs.

I do not have sufficient financial resources to pay the filing fees, printing costs, or other expenses associated with bringing this petition before the court. In addition to my financial condition, I currently reside in a home with a broken sewer pipe, which causes flooding in my basement. I have been unable to afford the repairs and have sought financial help through a GoFundMe page. Despite these efforts, I have not received any assistance to fix the problem.

WHEREFORE, I respectfully request that the Court grant me leave to proceed *In Forma Pauperis*.
