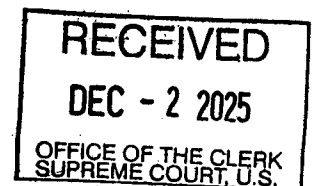


**AFFIDAVIT OR DECLARATION
