

Defendant was originally tried by a jury on charges of driving under the influence and causing bodily injury (Veh. Code, § 23153, subd. (a)), driving with a blood-alcohol level in excess of .08 percent and causing bodily injury (Veh. Code, § 23153, subd. (b)), and assault with a deadly weapon (Pen. Code, § 245, subd. (a)(1)). A mistrial was declared when the jury was unable to reach a verdict on any of the counts.

Shortly thereafter, defendant was arrested on charges of perjury (Pen. Code, § 118) and subornation of perjury (Pen. Code, § 127), these charges arising from circumstances relating to the first trial. When defendant, who was released on bail,

counsel with whom he could not work. Since we have already concluded that any and all difficulties defendant was experiencing with Pacheco were of his own intentional doing, he has failed to make the requisite showing of "reasonable cause for the lateness of the request." (People v. Burton, *supra*, 48 Cal.3d at p. 852.) Consequently, there was no abuse of discretion by the trial court in denying defendant's motion for self-representation.

The judgment is affirmed.
