Affiant, being first duly sworn, deposes and states as follows:

1. My name is Anthony Dove, and I am over eighteen years old.

2. I am the Plaintiff in Dove v. Broadwell, et al. (E.D.N.C. 5:18-CT-3143-D).

3. I am currently incarcerated at Nash Corrections, P.O. Box 600,  
Nashville, NC 27856.

4. On November 19, 2025 I deposited the enclosed petition for a writ of certiorari and supporting documents into the Nash Corrections mailbox.

5. On November 19, 2025 when I deposited the enclosed petition into the prison mailbox, I also sent a separate letter to the Prison mailroom requesting that the date my mail is received in the mailroom is stamped or written on the outside of the manila envelope because my deadline was growing close.

6. That first class postage was applied to manila envelope with said petition.

7. That on December 11, 2025 I received this enclosed letter, dated

December 4, 2025, from the Clerk of U.S. Supreme Court stating that, "The petition was not timely received and the postmark on the envelope is not legible."

8. That on December 11, 2025 I submitted a request to the Prison mailroom requesting a copy of the outgoing legal mail log verifying the date said petition was mailed to this Court.

9. That Nash Corrections have just hired two new staff members for the mailroom who are responsible for all of the mail at this 900-inmate prison.

10. The factual assertions set forth in this Affidavit are based on undersigned Petitioner's firsthand knowledge of this matter and are accurate to the best of his knowledge.


