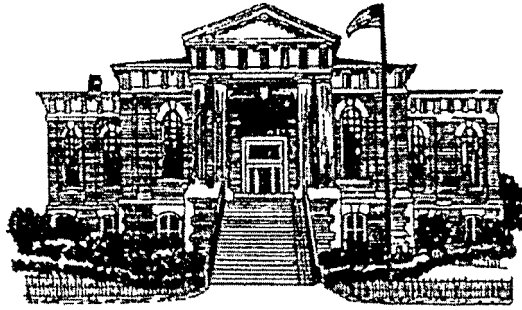



The written order extended the filing due date to December 27, 2024. Appellant was advised that "no further extensions will be allowed." Appellant was also provided notice that failure to file the brief by this date will result in the dismissal of his appeal without further notice. To date, no Brief has been filed.

The Court notes that the Appellant Brief was originally due to be filed on September 6, 2023. Appellant has filed 5 Motions for Extension of Time, and numerous other motions in lieu of filing his Brief. In addition, the Court notes that as a courtesy, it provided Appellant with a sample brief, a brief template, and instructions on how to compose a proper brief.

UPON REVIEW, THIS COURT FINDS that Appellant has failed to timely comply with Supreme Court Rule 341.

IT IS THEREFORE ORDERED that this cause be DISMISSED pursuant to Supreme Court Rule 375(a). APPEAL DISMISSED.
