As of 5:20 PM PST on Friday, February 27, 2026, the Clerk's Office and the District Court for
the Eastern District of Washington are in Administrative Default.

Despite multiple windows of opportunity and explicit inquiries regarding the integrity of the
court record, the Court has failed to account for the **criminal concealment and destruction of a
targeted 290-page forensic block**. These records, specifically identified as **Exhibits K through
V**, constitute conclusive evidence of criminal child trafficking and illegal property theft across
state and federal jurisdictions. The surgical removal of these exhibits, alongside the destruction
of the **Notice of Intent to Further Amend**, confirms a willful and targeted interference with
federal proceedings and the investigation of criminal activity. Understandably, the Court and its
staff may wish to refrain from further communication to avoid self-incrimination; however, that
silence now constitutes a direct and willful interference with federal proceedings and the

investigation of criminal activity. Therefore, the only remaining legal and ethical option is for the Court, on its own motion, to:

Mandatorily Disqualify itself from any and all cases, open or closed, in which I am a party;

1. Vacate all orders and judgments issued on the current mutilated record; and
2. Abate all current proceedings until a full forensic resolution of the court record is achieved.
3. Notice Regarding "Fraud on the Court" Filings: Be advised that I will not file any motions for "fraud on the court" or other claims within the Eastern District, Western District Court or Ninth Circuit. I already filed sworn Notices of Criminal Violations and reports of felonies which themselves (and their attached Conclusive Exhibits) have been targeted and wholly and or partially tampered with, concealed, and or destroyed). This Court (as well other others) is mandatorily disqualified as its members are named parties to the litigation currently pending in the Appellate Court (Case No. 25-3405). The Enterprise cannot "judge" the forensic integrity of its own mutilated records.

The Motive for Record Destruction: Cross-Jurisdictional Shielding The Plaintiff has recently uncovered the mechanism of this Enterprise's perceived impunity: the collaborative concealment and destruction of records between the Washington State judiciary and the Federal District Courts. This systemic "cleansing" of the record is designed to cover up a coordinated scheme of child trafficking, criminal theft, and the illegal seizure of private and federal properties. Members of this Enterprise, who also sit on the **Judicial Council of the Ninth Circuit**, have willfully failed to disclose these conflicts of interest on the record. It is now clear that these federal felonies were committed without fear of accountability because the perpetrators are the very individuals tasked with the "oversight" of the judiciary. This Council has been transformed from an administrative body into a clearinghouse for the forensic laundering of state and federal crimes.

Final Warning on Continued Jurisdiction: If the Court refrains from disqualification and abatement, such action will be documented as a series of new and continuing crimes—specifically, the willful interference with my active appeals to cover up and protect the Enterprise's involvement in child trafficking and the criminal seizure of property. Disqualifying yourselves and vacating all orders is the only path to resolution that avoids further federal and state criminal exposure for the ongoing cover-up.

Final Conclusion on the Failure of Manufactured Immunity: Be advised that the countless attempts by the Judges and members of the Ninth Circuit Judicial Council to "launder" reports of criminal violations—including the destruction, falsification, concealment, and electronic forgery of federal records—into standard judicial proceedings will no longer succeed. These efforts to cast a "manufactured immunity" over documented criminal acts are rendered null and void by the relentless, ongoing, and successive criminal acts documented herein. I am in receipt of the cost estimate provided by the Clerk's Office on February 24, 2026. Upon review, there appear to be material discrepancies between the estimate provided and the current status of the public docket for ECF 152. I am requesting an immediate correction of the estimate to reflect the following:

1. Correction of Attachment Indexing and Count The estimate provided accounts for only **seven (7) attachments**, whereas the public docket for ECF 152 explicitly lists **eight (8) attachments** (ECF 152-1 through 152-8).

ECF 152-1: This is the *Conditional Certification of Records* (5 pages). Your estimate lists this as a standalone item rather than "Attachment 1," which has caused a numerical shift in the indexing of all subsequent entries.

- **Missing Attachment 8:** Due to this re-indexing, your estimate concludes at "Attachment 7" (which corresponds to the docket entry for ECF 152-8). Consequently, the cost and certification for one full attachment have been omitted.

You are hereby formally notified that your **failure to act** on this communication will be treated as an **Affirmative Act of Concealment and Misprision of Felony** (18 U.S.C. § 4). You have an immediate, legal duty to report and abate the criminal suppression orders and the False Certification to federal authorities.

The Core Criminal Act: The Systemic Suppression, Concealment, Destruction and Tampering

A. The Conclusive Admission of Conspiracy (18 U.S.C. § 371 & § 1503)

1. **The Policy of Suppression:** Clerk **Courtney Piazza** later confirmed the illegal directive: "**The judge and the judicial assistant together.** They work together. [They tell you] **not to file. Don't docket those.**"

B. Execution of Tampering and Post-Acceptance Concealment / Destruction

The evidence conclusively establish that even when documents were accepted, they were deliberately destroyed or removed from the docketing stream, proving **tampering with the official record** (18 U.S.C. § 1506 and § 2071).

Courtney Piazza's Admission to Tampering/Removal: Clerk **Courtney Piazza** confirmed that documents are accepted but then suppressed based on instruction: "**If the judge were to say, though, here's what I want done with these documents, then that's what we do.**" This is an

admission that the judge exercises illegal control over which accepted filings are retained, justifying their removal from the record after filing.

1. **Renea's Admission of Acceptance and Suppression:** Clerk **Renea** confirmed this two-step process, where filings are accepted but their ultimate fate is determined by the judge's illegal order: "**I will take it and receive it... and give it to him, and if it is correct then its on you not us.**" The clear implication is that the *filing* is accepted, but the decision to docket or destroy the document is made afterward by the judge, confirming the **tampering** with the docketing process itself.
2. **Lee's Adamant Refusal (The Two-Part Strategy):** The Enterprise also used outright refusal as a tactic. Clerk **Lee** committed the Overt Act of obstruction by repeatedly and firmly refusing to accept filings. Her quote confirms the finality of the suppression: "**Sir, those documents are not going to be filed.**".
3. C. The Final Act of Falsification and Fraud

The evidence conclusively establish the fraudulent cover-up relied on these initial acts of tampering.

Prior Admission of Filing: Clerk **Courtney Piazza** confirmed the document was filed: "**Yes, it was,**" and "**we get it docketed.**"

1. **Subsequent False Certification:** Despite that admission, **Piazza** issued the official email in November 2025 certifying the entire docket as "**complete**", knowing the suppressed filing was missing. This confirms the **Falsification of Records** (18 U.S.C. § 1519) and **Wire Fraud** (18 U.S.C. § 1343).
2. D. Final Act of False Certification and Misprision of Felony (18 U.S.C. § 1519 & § 4)
