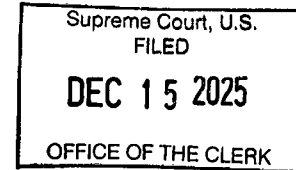

I cannot obtain employment due to the active arrest warrant that is the subject of this petition. The warrant, issued May 15, 2025, sets bail at \$10,000 for a Class B misdemeanor—over 14 times the \$680 statutory maximum. All positions in my field (cybersecurity) require extensive background checks. The active warrant makes me unemployable.

I was terminated from Zions Bancorporation while on FMLA leave in July 2025. I did not collect unemployment benefits. I have attempted to start my own business but cannot effectively operate or grow it while living under an unconstitutional warrant.

If this Court grants relief and the unconstitutional warrant is vacated, I would be able to seek employment and my financial situation would improve.

I am a cybersecurity professional with two master's degrees (Master of Science in Cybersecurity and Master's in Cybersecurity and Artificial Intelligence) and 12+ years of professional experience. Despite these qualifications, I am currently unemployable due to circumstances directly resulting from this case.

I was terminated from employment at Zions Bancorporation while on FMLA leave in July 2025—retaliation that extended the persecution documented in this petition into my workplace. I did not collect unemployment benefits.

I have an active arrest warrant issued on May 15, 2025, with unconstitutionally excessive bail of \$10,000 for a Class B misdemeanor (the statutory maximum is \$680). This warrant prevents me from passing any background check required for employment in my field.

I was forced from my housing despite never missing a rent payment of \$2,690 per month—always paid early, never late. I was never given a trial on the eviction. That case is currently on appeal. As found by Judge James D. Gardner on May 12, 2025, my son and I "are currently homeless and have been since September 2024." We have been moving from place to place—sometimes every few days, sometimes weekly.

I am caring for my minor son (born 2016) alone, with no income, no family support, and no ability to work while this unconstitutional warrant remains active. I am currently dependent on the assistance of others for basic necessities.

I have attempted to start my own business since I cannot obtain traditional employment with an active warrant, but I cannot effectively grow it under these circumstances.

I have previously been granted leave to proceed in forma pauperis by the United States District Court for the District of Utah (Case No. 2:25-cv-00465-TS, Docket No. 24, July 29, 2025), the United States Court of Appeals for the Tenth Circuit (Case No. 25-4081), and the Utah Supreme Court (Case No. 20250589-SC) in the proceedings below.
