Dear Mr. Bickell:

This letter is to request a second extension of 30 days to May 13, 2026, in which to file Respondent's Brief in Opposition in the above-styled case. Respondent's current deadline to file a response, with one extension, is April 13, 2026.

Respondent seeks this extension due to counsels' capital and non-capital habeas and direct appeal dockets and other work-related obligations. For counsel Yeatts, these duties have included filing Briefs in Opposition in *Broadnax v. Texas*, Nos. 25-939 and 25-938 (filed March 9, 2026 and March 25, 2026 respectively) and preparing responses to applications for a stay of execution in Nos. 25A900 and 25A899. Counsel is also researching and preparing the State's responses to applicant's third subsequent state habeas application in *Ex parte Broadnax*, No. WR-81,573-04 (in the Texas Court of Criminal Appeals) and applicant's motion to withdraw the execution order in *The State of Texas v. Broadnax*, No. F08-24667-Y (in the Criminal District Court No. 7 of Dallas County, Texas). For counsel Lambert, these duties have included assisting with an insanity murder trial in *The State of Texas v. Austin Tran*, No. F23-76580-P (in the 203rd Judicial District Court of Dallas County), which began on March 23, 2026, and preparing for an evidentiary habeas hearing in *Ex parte Darius Fields*, No. W19-00486-W(A) (in the 363rd Judicial District Court of Dallas County), scheduled for April 27, 2026. Additionally, both counsel are deputy chiefs of the Appellate Division of the Dallas County District Attorney's Office and have daily administrative duties including editing, trial support, assigning work, and managing attorneys within the division.

Petitioner does not have an execution date scheduled. Thank you for your consideration of this request.
