Petitioner has prolonged financial hardship since 2019, following the COVID-19 pandemic, resulting in approximate 48% reduction in income. January 14, 2024, a tree fell on Petitioner's primary residence, rendering the home uninhabitable causing extended displacement until late December 2025. Returning home Petitioner discovered additional structural damage due to faulty roof repairs, increasing financial strain. Reduced income, relocation expenses, ongoing housing losses — non liquid assets, Petitioner's expenses exceed income. The Supreme Court filing — non IFP and fee will cause undue hardship.
