ORDER DENYING MOTION FOR LEAVE TO FILE

Pursuant to a previous opinion of this court, the petitioner, Imre Kifor, is required to obtain leave from the court before filing "any new petition or appeal . . . that seeks extraordinary relief, by way of G. L. c. 211, § 3, or otherwise." Kifor v. Commonwealth & others (No. 1), 492 Mass. 1002 (2023). The court will grant leave if and only if Kifor demonstrates that he has no other adequate remedy and if he provides the court with a record to substantiate his claim. See id. Since the court imposed that requirement in 2023, Kifor has filed four motions for leave to file a G. L. c. 211, § 3, petition,

each of which has been denied. He has now filed a fifth such motion, with an accompanying petition entitled "Imre Kifor's Petition To Correct And Prevent Ongoing Errors Pursuant To G. L. c. 211, § 3, And G. L. c. 249, § 4, Caused By Agenda-Driven Organized Discriminations And Targeted Retaliations With A Racketeering Pattern," which we also hereby order is DENIED for the same reason that the previous four motions were denied: Kifor has not met the requirements set forth in our prior opinion, i.e., he has failed to demonstrate that he has no other adequate remedy.

All five of the petitions that Kifor has sought, and been denied, leave to file stem from the same underlying matters in the trial court, involving the same underlying litigation with the mothers of his children. Kifor's repeated efforts to file a new petition while failing to meet the requirements set forth in Kifor v. Commonwealth & others (No. 1), 492 Mass. 1002 (2023), now lead us take the following further action. It is FURTHER ORDERED that Kifor is hereby prohibited from filing any new papers, or from seeking to open any new case in the Supreme Judicial Court for the County of Suffolk, where such papers, or such new case, arise out of the same underlying trial court matters (including, but not limited to, Middlesex Family and Probate Court Nos. MI07D3172DV1, MI09W2177WD, MI11W0787WD, and MI11W1147WD; and Middlesex Superior Court Nos. 2081CV00109, 2281CV02933, 2481CV00983, and 2181CV00921, as well as any and all appeals taken from such matters). Any papers that Kifor hereafter submits to the Supreme Judicial Court for the County of Suffolk will be screened

prior to docketing; if they arise out the same underlying proceedings, the papers will not be accepted for filing. If Kifor continues to try to file any such papers, he risks further sanctions, including being held in contempt.
