Questions For Review:

1. Appealing To The United States Supreme Court To:

- a). Can The United States Supreme Court help Settle my Case with LEIDOS Inc.'s who have refused to compensate me after wrongfully terminating my employment?**
- b). Can The United States Supreme Court extend their hand of Justice and Mercy to help save my home?**
- c). Why has my lawsuit languished in the Courts for years without Relief and my persecution by Leidos Inc. and their Customer (AGC) continue to this day and close to losing my home?**
- d). Can The United States Supreme Court Remove The Time Limitations Of My Case Due To The 5 Long years of Age-discrimination, Victimization and Political Retribution at The BuckEYE-II of Leidos Inc. all of which extend for over many years?**
- e). Can The United States Supreme Court help uncover why Judge Brinkemma Dismiss my Case quickly at the Eastern District Court before a scheduled Hearing?**
- f1). Can The United States Supreme Court help uncover reasons why Leidos Inc. Managers in the BuckEYE-II Department and the "Customer" AGC (Army Geo-spatial Center), targeted me (at age 61), to have short training, then Deploy me overseas to a tough site, but did not deploy younger analysts better suited for the difficult conditions at the site, and who were willing to deploy to the site?**
- f2). Can The United States Supreme Court ask the BuckEYE II managers if I performed well for 5 years and then decide to gave me a short (5 week), training on a new Program compared to others?**
- f3). Can The United States Supreme Court ask Leidos Inc. and Buckeye managers if I was the only**

oldest employee to be deployed to a tough site?

f4). Can The United States Supreme Court ask them if I requested on numerous times not to deploy me due to my husband's severe illness and my plea ignored?

f5). Can The United States Supreme Court ask if one manager told me it was "unusual" for the Customer (AGC:Army Geospatial Center) to request that I be deployed to this very tough site?

F6). Can The United States Supreme Court ask them why, on all previous deployments, I was repeatedly placed on evening shift instead of day shift, which prevented me from learning day shift

programs and techniques, but used it against me if I failed to perform day-time task correctly?

g). Can The United States Supreme Court ask Leidos Inc. why its BuckEYE-II managers ignored my pleas to excuse me from the overseas Deployment while my husband was gravely ill in 2022?

h). Can The United States Supreme Court help uncover why I was spied-on and surveilled upon during Deployments overseas before I was Terminated?

i1). Why was I admonished in regards to Politics on the Signal App. before I was terminated, which occurred after a comment about "Term Limits" on members of Congress in June-July 2022?

i2). Why did I receive similar rebuke on my LinkedIn account on the same issue?

i3). Why did I receive a warning from a Tech-Company before I was terminated, in which I was being encouraged me to leave the US and go live elsewhere?

j). Why, did the Defendant, (Leidos Inc.) refuse to Settle with me in a reasonable manner at the Eastern District Court, but offered me only \$30,000 with the knowledge my mortgage balance was \$350,000 and unable to find employment due to the "Termination label" that Leidos Inc. unfairly put on my legacy?

k). Why did Leidos Inc. impede on my Freedom of Speech by terminating my job after political questions were repeatedly asked of me by a politically-motivated co-worker while deployed overseas?

2. Appealing To The United States Supreme Court To:

a1). Can The United States Supreme Court review the unfair Rulings by the Lower Courts when the Judge quickly dismissed my Case while ignoring a requested and scheduled Hearing?

a2). Why did Judge Brinkemma refuse to re-open the case but told to make an Appeal to the Court of Appeals in Richmond, but not at the 4th Circuit Court in Alexandria?

b). Why did Leidos Inc. request HIV-AIDS tests records, at the beginning of the Discovery period, which

had no relevance to the Case?

c). Though not HIV Positive, why was there a Court leak about my Case, and intimidation using my personal records?

a). Stop The Continuous Punishment By Leidos Inc. long after they wrongfully terminated me.

c3). Why did the politically-motivated BuckEYE-II managers entrap me using my innocent answers in response to questions asked of me by Nick Couture, who was sent to my deployment location for the sole purpose to sabotage me and enable my illegal termination? (** see Amended Complaint attached).

I am humbly asking the Supreme Court to prevent the loss and possible foreclosure of my home due to the Cruelty and Unusual Punishment by Leidos Inc. and its BuckEYE-II managers, who deliberately created this evil plan to Terminate me and Ruin my life, due to Political Retribution and Age-discrimination?

b). I am humbly asking The Supreme Court to Disregard The Time Limitations Of My Case due to my long years of Political Retribution and Victimization by The BuckEYE-II of Leidos Inc.?

c). Why is the Leidos Inc. attempting to hide their long history of victimization and Elder abuse by using

my young co-workers to work against me while on deployment, all planned by BuckEYE-II managers?

d1.) Why were my Civil Rights and Freedom of Speech violated for many years at Leidos Inc.?

d2). Why have the attacks continued to this day, with my personal information is being stolen and used to apply for loans?

d3). Why are Companies I had done business with in the past being hacked and my personal data being stolen to this day? (see attachments)**

Conclusion To Questions Above:

I thank the United States Supreme Court for looking into my long suffering Case of Wrongful Termination of Employment and Targeted Discrimination. I am humbly asking The United States Supreme Court, to restore Justice to my family where I have received no Compassion or Mercy from the Lower Courts. I am pleading to get the Relief I desperately need and deserve to avoid losing my only home and the only home my children grew up in. With no investments, with nothing to rely on, except my house, and at 64 years old, I am facing a brutal future. Without your help, this bleak future will continue to include the cruel on-going surveillance and my victimization by the same people. The surveillance makes it impossible for me to privately communicate with other people with my phone and text messages being hacked. I have proof of these violation which continue to happen even as I write.

****The fact that I have brought my Case to the Supreme Court, will only anger Leidos Inc. and its politically-motivated affiliated groups who they deployed to live near my home. I fear for my life everyday. Something has to be done to help me and my two autistic daughters, who depend on me. Losing my house will be a devastating blow to me and my special-needs children who grew up in this home. Everyday I am losing my Freedom, due to my Lawsuit against Leidos Inc.. Each day that passes, I am getting older and alone, (with my husband deceased) and unable to secure a job due to the termination label. Tools like AI are being used against me by Big Tech and Military Intelligence to Discredit me and destroy my Reputation, as evidenced by my inability to find work. Big Tech is also involved in my retribution and I have evidence to provide. **New neighbors with links to the BuckEYE-II managers have continued to reign havoc in and outside of my house, including targeted hacking of my home WiFi, mobile phones and laptop. Without income, I cannot effectively dispute the persecution being perpetrated on me. Many attempts to reach out to Prince William County Police or the County Magistrate, have failed due to efforts to discredit my claims to Authorities. Additionally, my personal information is being stolen on a regular basis as people have used my personal information to apply for loans that I did not apply to. Without income I cannot afford online security and other online services to help me keep my information safe.**

I am appealing to the United States Supreme Court to Intervene in my Case as everything else has failed. I believe my life is in danger if nothing is done. Many attempts to reach out to Civil Rights Lawyers have

Statement

Statement of Case:

Your Honor, the facts of my case are that I was wrongfully terminated by the LEIDOS BuckEYE Managers, after targeting me, at 61 years old, to deploy overseas after a short training period, while my husband was deathly ill. I was the first example of the Customer selecting a particular employee to deploy to a site overseas. This never happened before. They refused my earlier requests to switch to a non-deployable position due to my husband's illness, but they insisted that will only occur after my Philippines deployment, not before. A non-deployable position would have saved me from some of the discrimination I endured from my young co-workers during this and previous deployments.

The managers did not consider the fact that I should not even be deploying at that time due to my sick husband. I had to comply in fear of losing my job, especially after the Customer particularly targeted me for this deployment. The managers knew about my husband's ill health, but they chose to deploy me anyway. I also received very short Training for the new program, compared to other employees who got 8 months to a year of training on the new "Correlator" program. As well, the managers failed to consider my age (at 61) compared to 20 to 30 year old co-workers. The Military Camp in the Philippines had extremely tough living conditions.

Also, no one was ever treated the way I was because most co-workers received sufficient training and if not, which was common, they would receive high intensity training at the site, working closely with the Tech-Lead and other experienced Analysts. No one was ever sent home because as it was understood that working every day on 12-hour shifts would bring anyone to a proficient level due to the repetitious of the job. After 3 months at the job, most analysts were high performing. This is what happened all the time with other employees. But I was treated differently, by being unceremoniously removed from the Site and sent home for retraining, which was followed by illegal termination after 3 weeks of retraining.

For the previous 5 years, I was an excellent performing, hard-working, team-playing employee with no history of poor performance as confirmed by my yearly Reviews and 3% pay increase from 2017 to 2025.

My Civil Rights were also violated by some co-workers named in the law-suit above, from whom I endured elder abuse, lies that they told me in order to confuse me and my work, including calling me a liar, even after I told the truth, as well as being called a "pathetic" person and openly humiliated me while co-workers reminded each other not to tell the truth about me or my work. When I did something right, they send texts to each other to remind themselves that they were supposed to always tell the opposite of everything positive I did. These lies were told to SOM, (Site Operation Manager), no matter the circumstance. They mocked my accent and belittled me during the entire deployment. I have examples and dates of when these abuses occurred in the office.

My discrimination began with every deployment overseas. Throughout, I endured co-worker harassment, name-calling, ridicule, elder abuse, being looked down upon, being called a liar and pathetic person. I reported the abuses during debriefs, but BuckEYE managers did nothing. I was called the "N-word" while on a previous deployment in Italy. In the Philippines, I was yelled at and told to go back home and told the job was not for old people. I reported a lot of the issues during de-briefs to managers with the hope of improving deployment conditions. I made numerous recommendations including "Orientation Training" for new analysts, in order to help reduce these issues, but nothing much was ever done about it. Managers suggested changing who I deployed with and failed to understand more needed to be done. Just changing who I deployed with did not help either as this was a systemic problem that needed to be resolved properly. The discrimination over time by some managers, tech-leads, and some (mostly my young, mostly white co-workers), culminated in my termination on August 31st. My husband (now-deceased) was white and I have two bi-racial daughters and I do not discriminate against anyone.

On August 29, 2022, on my way to work after Philippines deployment, I was told to go back home and not to come to the office. They asked me to charge my hours to admin until my Line Manager calls me. On August 31st, the Line Manager called me on a Team's call, and told me I was being terminated, and I immediately lost access to all my work files and emails, which would have helped support my discrimination charge. Sick as he was, my husband asked me to immediately file an age-related Discrimination Complaint with the EEOC. My Discrimination Charge cited BuckEYE managers giving me a short training period to learn a new computer-processing program just before deployment to the new site that had tough living conditions not suitable for an elderly employee. **This never happened before to other employees who received 8 months to a year of training on the new program,

(Correlator), before deployment. I was the first to undergo such a short training course and then got terminated soon after due to what they called "unsatisfactory performance", without giving me enough time to improve, even while I was undergoing a family crisis with my husband deathly ill.

In the past, if anyone was sent on deployment without sufficient training, it was always understood that the employee would receive intensive training for the first few weeks after arrival at the site and would work closely with the Tech-Lead until he or she is proficient enough. This happened all the time and no one was ever sent home early, within just a few weeks like I was. I myself even helped to train a few employees who got to a site without sufficient training on previous deployments. Usually by the time you go home after deployment your skill levels have sky-rocketed because you are repeating the tasks every day for 3 months straight, while on 12-hour shifts. We deploy, often in hazardous conditions, only to do this job, nothing else, but when I deployed to the Philippines with the short training I had received, I thought I was going to get the same treatment that everyone else got, but that did not happen. I was sent home instead and wrongfully terminated soon after. Everything that was done to me was never done to anyone else before. My Philippines deployment and retraining period occurred while my husband was battling cancer and the managers knew I was under a lot of stress and should have postponed the retraining at once, but they did not. During the retraining period, and while my third training project was still running, they terminated me. My first and second projects went okay and on time, and there were no errors after I qceed my second project and I was very good at QC and other Tech-Leads would attest to this. However, my termination trainer claimed he found errors after he qceed it even though I had found no errors. I told him I did not find those errors myself and I maintain to this day, that either the trainer wanted me to be terminated or he simply qceed the wrong project. All my pleas were ignored, same way as they ignored my family crisis as they knew my husband was very ill, while juggling looking out for my two daughters who both have disabilities.

After working at Leidos for 5 years with good performance, the BuckEYE-II management and the Customer, targeted me, a 61-year-old (at the time), to deploy to the Philippines, where the living conditions were much tougher than other sites. A better fit for the site would have been a much younger employees all of whom wanted to deploy to the site. (An example of the tough conditions involved climbing a long treacherous flight of iron stairs that were wet and slippery almost everyday, due to daily downpours of rain. I struggled daily to avoid slipping and falling on the stairs, risking breaking a leg or worse, especially after taking a shower). I almost fell a few times straining my ankles and knees. At 61, I suffered from arthritis and took medicine for diabetes and high blood-pressure, all of which are common age-related illnesses, and my health condition was well known to managers. Targeting me to deploy to a difficult site, to me was Age Discrimination as no consideration was given to my age when they put me in this situation. While younger co-workers were pleading to go to the Philippines site instead of me, the managers dug their heads in the sand insisted on sending me to the difficult site while disregarding my husband's health, which I had repeatedly told them.

Your Honor(s), The United States Supreme Court, I am writing to appeal my case to the Highest Court of the Land, to hear my Complaint of Wrongful Termination by my former Employer, LEIDOS Inc. Your Court is my only last resort to receive Justice after the LEIDOS Inc., with no good cause, deliberately targeted me for Termination despite 5 years of good performance, but only took them the last 4 months of my employment to devise a plan to terminate me. LEIDOS Inc. put into motion starting in March or 2022, a series of actions that resulted with my termination. LEIDOS Inc. and its Army Contractor, (AGC) and Highly political BuckEYE-II managers and some co-workers, all have ruined my life and reputation. After wrongfully terminating me, the Company's managers in the BuckEYE-II Department, has continued with malicious character assassination of my name to this day. The result is no employer willing to hire me. The "termination" label has made it impossible to find work despite my vast 25-year experience in the GIS (geographic information systems) field. At 64 years old, without work and income, I am struggling financially and stand to lose my home and suffering with daily stress and despair at the prospect of becoming homeless and facing a bleak future. I am an educated well qualified, hard-working woman all my life with two-and-a-half College Degrees and even at 64 years, willing to work, but no one will hire me. I would like the High Court to hear and review the detailed circumstances of my politically targeted retribution at LEIDOS Inc. for my wrongful terminated after 5 years of satisfactory work performance. I have attached a copy of my previous Initial Complaint and Amended Complaint to the Courts since January 2023. I am Appealing to the Highest Court, because I still believe in the United States Justice System. Unfortunately, so far, in the Lower Court Judges have not Ruled with compassion, fairness and consideration of my very unique situation, where I have no lawyer helping me through this difficult journey and have made some unwitting legal mistakes in the 4th Circuit Eastern District Court. Despite the fact that I am not a Lawyer and could not find a lawyer to

represent me up to this day, I have been treated with cruelty and loathing by my former Employer and the Lower Courts, as evidenced by their consistent negative Rulings and delays, (kindly see attachments of Rulings). This, in spite of the EEOC determining that my case had merit and gave me the "Right To Sue". (EEOC copy attached). The Lower Courts have either Dismissed or Refused to Re-open my case after I unwittingly made the wrong decision, as I am not a lawyer. When I became ill and in pain, I misunderstood the Court process, I submitted a request for a Hearing and also submitted a motion with my intention to dismiss the case, after the Hearing, but the Judge dismissed the case without honoring my request for a Hearing. My intention to Dismiss was because I was in great pain and could not figure out how I could abide by Rule 26 in a timely manner and not suffer the consequences, as Judge Fitzpatrick had demanded. Your Honor(s), I did Request a Hearing on the Friday of the same week, but Judge Brinkema quickly Dismissed the case before the Hearing. The Judge did not honor my request for a Hearing. My plan was for the Judge to hear some of my concerns first, including how I was ill, and to discuss how she could intervene since she is the one who had transferred it to a different Judge, (Judge Fitzpatrick) for Settlement. My Hearing Request was never honored and the case was quickly Dismissed by her Ruling. The Dismissal Ruling came as a complete surprise to me as I was under the impression that in the Courts, if one request a Hearing, it will be honored, just as had happened before. To this day, I feel that the Judge should have kept my request for the Hearing in-order to discuss my concerns about the failed Settlement and beginning the "Discovery Phase". Instead I was told to file an Appeal to "Reopen" the Case in the Appeals Court in Richmond, which I did, but took almost 7 months for a Ruling from the Appeals Court. All my requests for speedy or expedited response were "Denied" by the Appeals Court on the same day.

Back during the Discovery Phase at the Eastern District Court with Judge Fitzpatrick, I felt the weight of all I had to get done to meet the deadline especially with the Judge stressing that I had to abide by Rule 26 by the designated date. Unfortunately, I became ill during the Discovery Phase and felt I could not go through with the case and needed medical attention. (I have evidence of the doctor appointments in regards to my illness, which I later provided to the Appeals Court after my case was Dismissed). During the Discovery phase, I became frustrated with the long court process while in severe pain, which prompted me into thinking of dropping the Case altogether. While in pain, I did not put much thought and never imagined the Judge dismissing the case before the Hearing. At the same time, I was juggling many things including being a care-giver for my two daughters both with Special-needs. My sudden illness and care-giving responsibilities were the basis of writing a Motion with Intention to Dismiss, but only after the Scheduled Hearing, which was never honored. At the same time, the unreasonable demands from the Defendant's requests for medical information (which included HIV) did not help matters for me because it opened my eyes as to which path the Defendant wanted to take. They wanted to embarrass and humiliate me throughout the court process. I realized they were planning to needlessly expose my medical records, which had no bearing to the case, though I was ready to comply with medical records that had direct bearing to the case only. Even Judge Fitzpatrick stepped in and asked the Defendant to remove

the request because HIV records had no relevance to the case. Besides, LEIDOS Inc. had all my medical history as an employee. Your Honor(s), even though I have no HIV and am not a Lawyer, common sense told me that making such requests by the Defendant, was continued efforts of harassment by my former employer, where I was constantly harassed during my entire employment at Leidos Inc.

Your Honor(s), I am battling continued stress related to my wrongful termination and continued surveillance and political persecution as the persecution that started at LEIDOS Inc has continued to this day. My phone is continually hacked resulting in exposing whom I am calling and each time a potential lawyer reviews my case, the result is the same, with the lawyer declining to take my case. The same is happening with potential employers who have rescinded my job offers. Your Honor(s), all this started during the previous (Biden Administration), but have continued to this day, despite that the current Administration stopped surveillance of American Citizens. My husband went to January 6th Rally but never engaged in any illegal act and never entered the Capitol Hall building and left early as he was ill from lung cancer. I have tried in vain to reach out to the current DOJ and FBI, but in vain. I believe my mail is not reaching the intended DOJ or FBI offices and is getting intercepted before it reaches them. My home WiFi and laptops are also hacked and am continually targeted with daily Cyber-Attacks around the clock, 24/7. My life has no moment of peace since my termination and am continually calling my WiFi Provider technical-support for help, all of which has perpetuated my persecution, since my wrongful termination in August 2022. I also know my termination resulted in my husband's untimely death and I still haven't had a real grieving period since his death as I am being continuously attacked. My husband was battling cancer and he passed away just two weeks after my wrongful termination, which greatly put him under great duress and he stopped eating. He knew I was being unfairly targeted, just as he was being targeted by helicopters and drones during the Biden Administration who were going after January 6th participants. (My husband was previously being targeted because, as a Conservative Journalist, he had written an Article regarding the origins of "Kwanza" in 2002 that resulted in the article and other future articles being removed while he became a target for De-platform on Social Media sites). Before he passed away, my husband saw low-flying aircraft and drones wherever he went daily, which troubled him a lot.

Everyday is nothing but a struggle for me since my wrongful termination in August 2022. The passing of my spouse and the continued attacks by neighbors who continue monitoring me and my children in my house and everywhere I go, just as they did to my husband, has given me no peace. I am forced to shut my phone while in the house for fear of hacking. Even as I write, I cannot access my own home WiFi due to the constant targeting of my WiFi-router in my house. As a result, I forced to use the unsecured Prince William County Libraries to check my emails, use the printer etc,. My emails and every website I visit at the library are tracked and hacked. I have evidence of these occurrences. I even reported the incidences to Police, but the Prince William Police did not help and did not investigate my complaint or other complaints I have made about cyber attacks.

My termination was preceded by the endless embarrassments, ridicule and shaming that I endured at the hands of co-workers, in particular, Diana Toohey, Chris Woodring, Nick Couture and others, including my new Line Manager, Jack Buttler and Deployment manager, Josh Ashburn. All are mentioned in my original Complaint to the Eastern District Court. It was the Company's plan to make the legal process very painful to me by requesting HIV records not relevant to the case, which was made evident by the Defendant refusing to make a reasonable Settlement accommodations with me and offering only \$30,000, where my total mortgage balance at the time was \$360,000 and I expected them to at least meet me halfway to at least cover my mortgage considering they had ruined and destroyed my life by terminating me and I could no longer find work, but they offered me only \$30,000 which included signing an NDA Agreement with a litany of Restrictions on what I could or could not say about LEIDOS Inc. in the future. I could have easily agreed to such an arrangement if they covered my mortgage, but the Company maintained a hard line. I refused the Settlement and Judge Fitzpatrick said the next step was Discovery Phase. At the next Hearing, the Judge then threatened that I had to submit all the information required for Discovery and abide by Rule 21 within the allowed time limit to avoid the "Consequences" indicated by the Judge. Without help from any lawyer, I started working on this, but unfortunately, I became sick due extreme stress brought by the mountain of demands from the Defendant and Rule 21. Your Honors, I am not a lawyer and could not find a lawyer and became sick that I found no way out at the time. The result was my unwitting and unfortunate decision to submit to the Court Clerk, two documents on the same day: 1. First document requesting a Hearing with Judge Brinkema, which the Clerk scheduled on Friday of the same week, because Hearings are scheduled on Fridays only as the Court Clerk pointed out.. 2. Second document with my intention to drop the case outlining a range of difficulties I was facing, including my illness, strange email I received soon after the Settlement, plus continued phone and WiFi hacking at home, on-going surveillance (air, signal and human) and harassment by neighbors, all who are connected to my former Employer, including my inability and failure to locate my former Line manager (who no longer works at LEIDOS Inc.), after online searches and asking ex co-workers. My intentions was for the Judge to hear my pleas about how difficult it was for me to come up with all the Discovery phase requirements and abide by the Rule 21 in a timely, all without good access to WiFi in my home. I did not want to suffer the "consequences" as the Judge Fitzpatrick had indicated in court and I submitted the two documents at the same time. But Judge Brinkema quickly Dismissed the case before the scheduled Hearing day. I wanted the Judge to hear my concerns first and foremost, including that I was ill, and to discuss how she could intervene for a better Settlement with the Defendant, since she had moved the Settlement to Judge Fitzpatrick. Unfortunately my Hearing Request was never honored and the case was quickly Dismissed. I immediately filed a Motion to Re-open my case (kindly see the attachment of my Plea to Judge Brinkema to Re-Open my case), but the Court Clerk told me my only recourse was to make an Appeal to the Court of Appeals in Richmond. I paid the fee and appealed to the Court of Appeals where my case was held up to 7 months with no word from the Court, until October 27th. In the interim, I appealed to the Appeals

Court up to 3 times for a speedy or expedited decision from the court, given the time limitation of the case. The Appeals Court finally made a Denial Ruling on all my pleas, on the same day, October 27th, where all my Pleas to Expedite were Denied. Then the Appeals Court also Ruled to Uphold the previous Court's Decision, not to Re-open.

Your Honor(s), it feels as though I am suffering death by a thousand cuts with no end in sight for the last 3 years including the death of my husband. First, I was wrongfully terminated, a label that ensures one can never work in the Defense Industry or anywhere else ever again. The Company has ruined my life and my reputation is decimated. Lies are being told about me and my personal data being sold on the dark-web by Data Brokers. Big Tech, (Microsoft, Google and a few others) is also involved in my suffering and I have evidence of it. My letters to the DOJ and FBI are being intercepted with no follow-up feedback. When I try making calls to government agencies to follow up, my calls get re-directed to commercial entities whom I did not call. I have been forced to change phone numbers in an attempt to avoid the abuses. The people doing this have place devices in my car and am being tracked everywhere my children and I go, including grocery stores.

I have only a few months of savings left to pay my mortgage before I completely run out of funds and lose my home. I cannot find work, due to targeted hacking my phone, my WiFi, my emails long after my termination by Leidos Inc. My persecution continues to this day and it is directly linked to my previous employer where I endured discrimination and political persecution even though I never engaged in political talk unless my co-workers prompted me to make a comment on a topic. My husband, who was Catholic and a Conservative, and attended the January 6th Rally in 2021, (before his death), endured extreme surveillance by Aircraft and Drones on a daily basis as mentioned above. Though my house is located next to the Quantico Marine Base, the amount of drones, helicopters above our heads quadrupled like never before and couldn't help but notice we were being followed, which is very troubling. When I was still employed, I was escorted daily from work all the way home and vice-versa, by aircraft on I-95 and sometimes on US-Rt-1. We have photos and videos of some of these events because I soon realized without evidence, I will not be believed. Even today, I continue to be under monitoring in my home and politically-motivated neighbors who use communication Apps to track my movements. This includes being followed everywhere I go all over Northern Virginia, DC and Maryland including grocery stores. The persecution continues to this day with no end in sight and I have nowhere to turn.

The Supreme Court is my only last hope. People around my home are getting paid to stay home and attack my WiFi 24/7 by hacking it, in an effort to prevent me from reaching out to the Current Federal Government, DOJ and FBI. This is happening even as I write this Plea to the Supreme Court. I call many times, my WiFi provider to give me a record of these numerous incidents of my WiFi being hacking to no avail. My WiFi provider possesses these records, but have refused to send them to me despite my numerous requests. I call my Provider Technical Support all the time for help and each time they create an Incident Report to keep a record of the hacking incident. My husband wrote a letters to

Members of Congress before his death, which I mailed, but were never received. It appears someone in the Triangle Post Office removed the mail being send to members of Congress. There is a lot of the abuses, illegal surveillance being carried out on me and I do not know what they want from me, but I know my former employer is involved in all based on what happened to me during employment. I cannot include all the attacks that I am under-going in the interest of time as they are too many and constant. These attacks are politically motivated and they make me feel as though I am living in a different country, not the United States. People tend to be afraid when I tell them what is going on, and they fear being targeted themselves. I am desperate to get the DOJ and FBI to Investigate what is going on in Prince William County as crimes are being committed against me with no end in sight. There is a direct connection between my former employer, Leidos Inc and all that is happening to me today in my County and it is a concerted effort to completely ruin my life. Big Tech is also involved and I have evidence of this. I am pleading for help from the High Court, because this is Civil Rights abuse issue of an innocent family and has to be stopped. I am afraid for my life and I have examples of incidences, photos and videos I try to take as evidence.

Your Honor(s), I am suffering emotional distress every day I wake up, knowing I have been maliciously discriminated and wrongfully terminated by my former Employer and continue to suffer to this day, and I am nowhere near getting the Justice and Mercy I deserve. I did nothing wrong, my husband did nothing wrong, and am the victim in all this, but the Lower Courts have treated me with contempt, disdain and cruelty without even consideration of what happened to me at Leidos Inc. and that I am not a lawyer and made sincere mistakes for which the Lower Court Judges have used against me and Ruled to Dismiss the Case. This is why the Supreme Court is my last hope for Fairness and Justice.

Your Honor(s), I do not have external support for me and my children as I was not born in America, but became a US Citizen and through education and hard work, I had good jobs and helped support my family and was a positive member of Society, until I lost my job. My husband Malcolm A. Kline, was heart-broken by my termination, and passed away within two weeks after my termination. Malcolm A. Kline was an American-born Catholic and Conservative Journalist whose focus was education, but constantly wrote Political Articles exposing the other side's inaccuracies and got DE-platformed on most social websites, (Face Book and Twitter). I believe this is how our family initially became political targets in Prince William County, and by the time he attended the January 6th Political Rally in 2021, they began full-blown surveillance on our family as well as at my job, at Leidos Inc.. I believe this is the real reason for my termination and the cruel manner they carried it out. It also help explain why I could not find a lawyer to represent me to this day as the Customer (AGC) is involved in my case against Leidos Inc.. LEIDOS Inc.'s Government Customer (AGC) targeted me personally to deploy at 61-years old, to a difficult site in the Philippines in June 2022, while my husband was sick. I became a target for verbal abuse by Nick Couture while on this last deployment. Nick was sent to target me specifically. (See attached record of how he treated me until I was sent home). Any other reasonable Company would have given me time off to take care of a sick spouse, but Leidos Inc. didn't, because their plan to terminate me was already put in

motion.

Your Honor(s), I am also a mother to a U.S. Veteran who is suffering from PTSD and has lost a lot of his Army comrades to suicide, which has kept him under depression and medications. LEIDOS Inc.'s BuckEYE managers and the Customer (AGC), had no regard for my son's Service in Afghanistan where he was a Corpse-man with the Marines. But the Leidos Inc. BuckEYE managers had depraved hearts and no regard for his service, but decided to go after his mother instead. They also refused to give me time off to help my sick husband after they sent me home after deployment. My husband died soon after my job termination. The managers had no compassion for my ill husband and my special-needs children, though I mentioned my family's dire situation to them. With the termination label over my name and with no prospect of working in my field again, with my working years getting shorter, (I am 64), all I can do now is put my life in God's Hands and the Supreme Court.

Your Honor(s), I am pleading to your High Court to make a positive Ruling in my case I have suffered for too without Justice. In my family, I am responsible for my two daughters with special needs, including my Veteran adult son who also needs my help. LEIDOS Inc., deliberately made me destitute and I need your help from certain disaster my family is facing through no fault of my own. My children are suffering everyday as they watch their mother endure the daily suffering of surveillance and attacks with no income and impending loss of the only house they grew up in. One of my Autistic daughters is in a group home due to the high level of care she requires and comes home every weekend. I am working to put my other girl in a group home as well in the event I lose my house in the coming months. Without your positive intervention your Honor(s), I stand to be homeless in my old age, with nothing to show for my high-level education, hard work and good work ethics I have always demonstrated throughout my life. President Trump has repeatedly said something like, ("if they can go after me, imagine what they can do ordinary American Citizens")? Your Honor(s), I am one such citizen under attack, suffering in silence under-going despicable abuses with no help from anyone. Please Help me and with God's Help, I am praying for a positive outcome from the Supreme Court because if you don't, I fear for my life from continued surveillance and continued suffering of my special-needs children and my adult veteran son who is undergoing stress after his Service in Afghanistan.

Reasons For Relief And Charges Breakdown

1- (103K-93K)X (7 years)=approx.. \$690.000 + 401 contribution. (This is approximately how much I would have made financially if I was not terminated and stayed at my job for 7 more years before I retire. I believe the amount I am seeking is very reasonable, and close to similar cases).

2- Termination is a Harsh, Cruel and Unusual Punishment and Continuous for a person who worked so hard for Leidos for 5 years. I was proud of working for Leidos and for AGC, (The Army Geospatial Center) through which Leidos had the Contract which I worked for.

3- I did not commit a crime, kill a person or sell company secrets, and yet I am now sentenced to a life of poverty for the rest of my natural life as no Employer contracting with the government will give me a chance to work. The word has gone out and have been character assassinated and banned to work in my beloved geography field. As well, this is unfair to all my children, especially my son, a former navy-corpsman.

4- Our son joined the military after high school because we loved this country. But, now as a veteran, my son is very disillusioned because he fought for this country in Afghanistan where he was embedded with the Marines and was the medic who helped treat his fellow soldiers as well as local people who needed help while deployed.

5- I am suffering daily emotional distress every day since the termination and the "Termination Label" is a death sentence to me and it indirectly caused my husband's death as he became very depressed by the whole thing and the unfairness of it all that he could not eat and died just within two weeks after my termination.

6- The "Termination" took away my ability to ever earn a living again in my field.

7- The "Termination" ruined my life after years of giving so much to this country, I worked hard, my husband and I paid all our taxes, are a good patriotic family, law-abiding citizens.

8- I could not even receive "Un-Employment Compensation" due to termination label even after trying to explain my wrongful termination to the VEC to no avail.

9- "Termination" is equal to continued extreme punishment with no end in sight. Every day, I ask myself, "what did I do to deserve such cruelty at the hands of the BuckEYE managers"? After all, my performance reviews were satisfactory for the previous 5 years. Also, I have never been terminated ever before after working at the similar companies, namely: (Kindly see my resume attached).

Pleading for Justice and Mercy:

Your Honor, the EEOC clearly saw my case had merit and attempted remediation. But their investigators could not find anyone to collaborate with what happened to me. Co-workers who were deployed with me in the Philippines refused to talk or tell the truth to the EEOC investigator, while others told lies about me instead. No one wanted to substantiate what happened to me on deployment, or else they might lose their jobs, I believe. One co-worker insisted he heard nothing even

while Nick was actively shouting cursing words at me, even though he was sitting there in the office while it happened. To me, this silence from co-workers at the site, is astonishing and a clear indication this was all planned and they encouraged other co-workers not to collaborate what happened to me.

**They removed me from the BuckEYE-II Program, where I had been performing exceptionally well and had improved substantially in my capacity to run complex processing and QC programs. I am a hard-worker and very good at my work and was becoming increasingly proficient with multiple programs in the BuckEYE-II Program, as well as encouraging my younger co-workers to do more. But it seemed my new Line Manager, (Jack Buttler), arrived with other plans for me.

**First, he never communicated with me as he was supposed to, after my old Line-Manager, (Kyle Ryan) left the job. Second, Jack Butler and others, (Josh Ashburn and the customer), decided to deploy me without full preparation, with no regard to my age and my sick husband, which I had repeatedly brought to their attention and my request to switch to a non-deployable position.

(CRUELTY AND APATHY Of BuckEYE Managers)

No One Cared About My Plight at the BuckEYE:

I still cannot believe the level of cruelty I have received at Leidos. When I got back to the US, there was no mercy. The "retraining" process was very stressful with the trainer, Craig Hoaglin. This was excruciating for me, especially due to my husband's health which was deteriorating each day. My husband was also distressed at the prospect of me losing my job as he knew I might lose my job. Every day, I would come home extremely exhausted from the training and couldn't do enough to help my husband, while his condition continued to get worse. I told the managers I was under a lot of stress, juggling everything: training, taking care of my sick spouse, worrying about him while I was training as well as looking out on my two daughters, who both have special needs. The managers were fully aware of all my family difficulties, but none of them asked me to take time off and return later for the re-training afterwards.

****I still can not believe the level of apathy to this day.**

I asked Amy to postpone everything so that I can take some time off to take care of my husband. I explained to her that I had no relatives to help me having emigrated to the USA, and my husband was an only child and none of his relatives lived in Virginia.

***This was a very difficult time for me and Amy and other managers failed to do the right thing. It was if they just wanted to get it over with early and have me terminated and leave the company quickly. They did not want to stop the "victimization" they had started. They had depraved hearts and failed to be compassionate, and they did not treat me like a human being should be treated. The whole thing resulted in my husband passing away not long after the termination.**

****As of this day, I never received a condolence card to this day from the BuckEYE managers. **None of my co-workers have ever been subjected to this treatment, even though the BuckEYE managers like to claim it was their customary practice, but there are no such examples that existed the 5 years I was employed.** As I look back, I now know that this was all planned in order to terminate me on their targeted day. They could have easily left me alone to continue working on my current program, but they removed me from it to start an entirely new program.

I worked at Leidos for 5 years and received good performance reviews during work performance reviews for 4.5 years. But in March of 2022, I was ordered to switch from the (The BuckEYE-II Program), that I had worked successfully for years, where I had produced good and satisfactory results every year. But they decided to transfer me to a new program, where I had to learn a new program, "Correlator", from scratch and received shortest amount of training before the fateful deployment.

Why am I suing?: I Am Fighting For My Life, For My Survival:

1. They took away my livelihood, so close to my retirement. I had planned to work for an additional 4-7 more years until retirement, which would have enabled me pay-off my house and contribute more to my 401K, for retirement. ****But now, I am facing a bleak future and looking to lose my home soon as I am struggling to pay my mortgage right now and my savings depleted. I have no healthcare and forced to pay everything out of pocket.**

2. I cannot find a job in the Intelligence Community (IC) geo-spatial field anymore due to the Termination label. No one is willing to hire me now, as I am considered damaged goods. It's almost as if someone is working overtime to ensure I never work in the IC industry again. Even changing from "termination" to "resigned" will not solve these problems at this point.

3. Example 1: I was offered a job by a defense contracting company in April 2024, and a week afterward, I received a call from the company telling me they are rescinding my job offer because the DOD contract was rescinded. This continues to happen to me today.

4. Example 2: If an employer finds out about my termination status, they become suspicious of me and begin to discriminate against me. This just happened to me at my, last short-lived job at the DHS.

5. Example 3.: Even job sites are asking me if I have been terminated before they sign me on, because they already know I was terminated and think something is wrong with me and will not assist me finding jobs any longer.

6. Even if by some miracle I find a job, my confidence has been shattered by all these lies about me as a geographer and a GIS analyst. The same things done to me might be done again and it appears someone is spreading a lot of untruthful things about me online, tainting my name for life.

7. 1. Your Honor, the BuckEYE managers terminated me with no Severance Pay, despite my good record of positive performance for 4.5 years at Leidos. Many of my co-workers know this and are willing to testify if subpoenaed to support me, because they witnessed the unbelievable treatment I received.

Continuous Punishment:

8. Your Honor, no company in the Intelligence Community (IC), is willing to hire me based on what my previous employer categorized me as "TERMINATED". This means it is no longer possible for me to be hired by any Government Contractor and the word has gone out already. Even if I asked Leidos to change my "Termination" to "Resignation", it will still not help me, because my life has already been ruined. Government Agencies are like one big organization and once my profile has been tainted with termination, it is too late to reverse the record. With so many jobs already applied to in vain, I believe I will never be able to work in my field ever again or any other field, except menial jobs with little pay. I am a geography professional with extensive years of experience in the field of geography, but, my name has been **character assassinated** so much that no employer wants to give me a chance. I am continually receiving rejection after rejection in every job application I make, even after an interview or a job offer. At first, employers are impressed with my resume and interview, then a background check is done and next, a rejection letter follows. Some do not even respond to my follow-up emails. It is almost as if someone is making sure I never work again, and I don't know why Your Honor. How will I survive and how will I pay my mortgage if I cannot even find work? Even if, for the sake of argument, I was such a bad performer on my last deployment, (which is not all true), I still do not deserve to die a destitute woman with no money to pay my mortgage and live on the streets.

9. Your Honor, this Termination Punishment does not match the "crime" so to speak. It is as if the BuckEYE managers were viciously retaliating against me for something I did: a)- I did not sell company secrets; b)- I did not betray my country. c)- I love my adopted country and would rather die than do anything illegal. d)- I was born a Christian and am a Patriotic American just like my deceased husband was. e)- I know right from wrong. f) I adhered very strictly to DEI as required by the Leidos. g)- I did not preach my Christian faith to others at work. h)- I am not a political activist, do not attend rallies or talk politics and do not have social media accounts. (On the other hand, during work deployment, Nick Couture asked all co-workers what their views were on politics. He is the one who forced people to talk about politics, not the other way round. I am a mother of 3, with a son who is a navy veteran and two girls with disabilities. My concerns are for my children and my health, not politics and I am neutral as to who wins the coming elections. I did not come to America to engage in politics, and yet my termination seem to be politically motivated as well. I came to the US to work, take care of my family, be a law-abiding member of society and pay my taxes dutifully, all which I did for 40-years.

10. *Your Honor, the fact that I could not even find a Lawyer to represent me, is proof that my victimization is connected to people from my former employer. It appears the same BuckEYE managers, Nick Couture and others, are continuing with their persecution of me, even while I am unemployed and suffering. Most lawyers said I had a good case, but strangely were afraid to take the case and represent me.

11. ****The victimization has continued to this day as I have endured daily harassment from new neighbors who moved in next door not long before I lost my job at Leidos Inc., These neighbors knew of my termination and were cheering after I lost the job. The day was told to turn around and go back home to wait for the call from my Line Manager, on August 29th, 2022, those neighbors were standing in front of their house and seem to be cheering and laughing at me. My husband and I fully suspected that the termination of my job seemed directly connected to these neighbor's strange behaviors. They continue to harassment me to this day, and I am working to report them to local authorities. Nick Couture is involved with these neighbors who are harassing me and persecuting me daily, even after my husband's death. They are sending people to follow me everywhere I go and illegally geo-locating me using cellphones and other devices. Things are so bad for me Your Honor and I am scared for my life.**

12. In addition, the termination label made it impossible to receive Unemployment Compensation. The VEC demanded reasons why I was terminated. They kept asking for detailed explanation, which I did, but they became more and more suspicious of why I was terminated and created extreme demands that made it impossible to apply for benefits and harder to communicate with them, that I just gave up.

Conclusion:

Your Honor, I gave Leidos my blood and sweat through my hard work for 5 years but got nothing in return for it after I was wrongfully terminated with no benefits and ability for future work. I am suing Leidos, my former employer, because the BuckEYE managers discriminated against me and unfairly terminated me, making it impossible for me to earn a living and survive in this country, a widow at the age of 63, with no way to pay my mortgage. I did nothing wrong to deserve this. I immediately became a widow soon after the wrongful termination on August 31st, 2022. My husband was not a rich man, and he left me and the children nothing after his untimely death. I came to this country as a young person with high hopes for success for my future and family. I believed in this country and I still do. Many countries around the world have no rule of law and ordinary people like me have no personal civil rights of any kind. Your Honor, it is my greatest hope that you will find that I deserve to be paid the amount I have cited in order to help me pay my mortgage and bills and to be able to live a decent life in my old age. I am only looking to be paid an amount close to what I would have made had I stayed employed until I retire, all of which includes the damages and emotional distress that the termination label has caused me. I am not asking for a millions of dollars like other examples in my situation. I am not looking to bankrupt Leidos Inc. All I ask is to see the BuckEYE Department return to doing good work for the Customer, as we used to do without the involvement of politics and targeting of the elderly employees.

****This is why I am suing, your Honor. The BuckEYE's Leidos, caused this to happen to me. I am hoping and praying for JUSTICE, Your Honor, and I believe that, though I am not a lawyer, my writing is sufficient for Your Honor to make a favorable decision to right the wrongs done to me, a widow with special-needs daughters who desperately need me to be there for them, as well as a son who is a veteran who fought for this country and is suffering today from PTSD his tour of duty in Afghanistan. I still believe that in America, an ordinary person like me can still get justice after my civil rights have been seriously violated by managers and co-workers of a powerful company at LEIDOS Inc.**

I am appealing to the United States
Supreme Court to intervene in my
case which has gone on for too long
as my life is in danger and I
continue to be victimized.

Please help me. Thank you.

CONCLUSION

The petition for a writ of certiorari should be granted.
