

2. The legal mail contained a letter from the clerk of the court ref; Application #25A201, granting petitioner a extension of time to file a "petition for Writ of Certiorari" from Justice Alito, who on August 21, 2025, extended time to and including September 13, 2025.

Upon receipt of the legal mail, the clerk at the mailroom did not have petitioner sign the legal mail register for receiving legal mail IAW; Section IV(E), page 117, Offender Orientation Handbook, Feb. 2017, which provides "The mailroom shall keep a record showing the source and destination of all incoming and outgoing legal, special and media correspondence." Mr. Lively, my supervisor was a witness to this action. (Statement attached Exh. "A"). It also appeared that sometime during the week the mail clerk attempted to deliver the mail, however, I was at work which is down the hall from my housing unit. (attached Exh. "B".) I received the legal mail six(6) days after the deadline to file the writ of certiorari. This was of no fault of my own.

4. Petitione# also acknowledge that due to the extremely long delay in receiving a response from the court that petitioner mailed his writ of certiorari on September 16, 2025, in hope of not missing any deadline. However, the deadline had already passed at that time. Petitioner is unsure as to what steps if any he is able to take at this time.
