This is a case like the John Gotti case a 10 week case not a one time event. Literally a criminal marathon like Bonnie & Clyde, 1934. I can try to shorten the legal, procedural, criminal, administrative, and constitutional jurisprudence of this case down to 10 weeks. Or less than to about 8 weeks court days. Or the Judges have the choice of HPCSI and CAT, 1984. Article 13. Mandamus to seize all operations on me and I'll see you in 3 months and allow HPCSI whom I trust to do their work. Nobody has ever reviewed my entire file and nobody can say shit about me due to this fact. To review my entire file will take 3 months. And they all have no fucking clue and are clueless. Only one SIU Investigator ever did this in January - February 2020. And she removed herself from this case entirely. Couldn't stand what has been done to me. I understand the Court's busy schedule and we should just leave this impartial

investigation to HPCSI. This case means the impeachment of Donald Trump and criminal charges, Bondi, Patel and Wray. Criminal Procedures Act is mandatory for this Conspiracy to Murder case.

I require this Mandamus to stop all operations on me because it's 100% an illegal false accusations operation. This case should have been mediated and settled 400 days ago. Yes, make a mockery of me as I tell you to bring \$100 dollars each for the lessons in the courtroom because I don't give free law lessons any more. Then you can thank me, I promise to leave the shits and fucks out of courtroom as much as possible. Maybe next time don't tell and weaponize the FBI and DOJ Investigators to do sick and disturbing shit, they are very good at it and super creative. Like sending a police dog after an innocent Chinese descent American born person for no reason walking on the sidewalk. How is that not abusing the FBI and DOJ Agents. Negligence and gross negligence would be the purges case. Administrative and procedural like no warrants or a bivens claim. But the cause of action against the United States is always negligence or wrongdoing. While working within the scope of your employment. Or under color of law. DOJ INTERIM DECISION #3990 "UNDER COLOR OF LAW" STATED IN 18 USC 2340.
