HERE'S MY LEFTOVER GARBAGE

I'm outraged at this point. Trying to type anything on a computer for 3 1/2 months every single time being deleted and destroyed paperwork. For the past 400 days a 24 hour operation on me to obstruct me from all Courts in the United States and Congress. February 28, 2026, 11:30am. All my paperwork has absolutely been destroyed to complain and there must be a better way to access Judges in the future after this case for impeachment of future Presidents and his Agencies. By the time a Victim reaches help he's dead. These laws are under the presumption that the conduct is not happening and happened in the past. Not that they are continuous violations 24/7 for the purposes of Obstruction of Justice. The actions of the Judges in this case either encourages "murdering Victims" or "protecting victims" of abuses of power. The future lawsuit for February 28, 2026 in the future will be \$5 Trillion Dollars. It's the discretionary decisions I am suing for. And the FBI and DOJ Investigating actually following the assignment intentionally. They all have a sworn oath to uphold the laws, protect the American public. They are taking a shit on their own oaths and sworn lives to the laws of the United States and fucking their lives.

To make things clear, Trump sued for Neural-data illegal use on him during the 2023 8 months of investigations resulting in 91 criminal charges in 2023. He had Bondi have the check for \$250 million dollars ready in October 2025 before he even filed lawsuit at the Courts. There was a Congress Hearing for this fact. The FBI had legitimate warrants but there's no neural-data warrants available yet. My lawsuit for \$500 million in October 2024 was rejected by Trump and decision to "murder the plaintiff" because he took it personally instead of accountability to the governed. ONLY TRUMP CAN SUE BUT NO OTHER AMERICAN IS ALLOWED. HE WILL GET AGENCY MURDERED. Every day in February 2026 has been Attempted Extrajudicial Killing" by Donald Trump to evade these criminal charges with Agency Chemical Weapons and Hybrid/ Chemical Nerve Warfare on me including Neural- Data Technology. My lawsuit for \$500 million

was the exact same as his, but for 3 years and there were no criminal charges against me resulted whatsoever because I'm not a child rapist, only one 15 year old for me not as pretty as 13 year old Katie Johnson that Trump fucked and sexual cruelty. Her interviews on this matter were extremely disturbing and her lawsuit in 2016 was equally disturbing when I studied the motions from that lawsuit. Saying "knowledge is KING" in the financial world and bragging about money to little girls who don't even know what money is and more worried about their training bras. Epstein got hung for his neural-data and I salute those FBI agents for it. Great job everybody.

This is very clearly established that the Administration, US Attorney General, and FBI Director constitute collectively "THE UNITED STATES". FTCA Act, 1946 states that any settlement or case must be approved by the Administration, US Attorney General and the FBI Director, equal to the Strzok and Lisa Page (even though she's a promiscuous one) "FBI Conspiracy" lawsuit settlement by Wray, Garland and the Biden Administration. Trump delusional crying "FBI CONSPIRACY against him over one text message". The CAT, 1984 is very clearly established and very clearly interpreted and texted Congressional Directive to only be used against the United States and cannot be used against any other. Whether it's used congruently with the FTCA Act, 1946 and Law Enforcement Proviso of 1974. Or the Crimes Against Humanity Act, 2010, #5 is dependent on the circumstances. This is 100% a criminal matter and criminal procedures, Criminal Procedures Act are absolutely mandatory. The CAT, 1984 Ratification #1 clearly states that the United States is bound by this convention pursuant to Article 16. The CAT, 1984 Redress Program from Redress.org. clearly states that Article 16 applies to all articles of the CAT from Articles 3-16. Including Articles 13, 14 my favorites. And pursuant to the Fifth, Eighth, and Fourteenth Amendments. My case is Fifth Amendment (neural-data) illegal interrogations, "right to remain silent", pleading the fifth. Fourth Amendment, Warrant Clause protects the Houses, Person, Effects. Protecting the person is protecting the mind. Right to Mental Privacy, and Federal Freedom of Thought and Expression ACHR, 1969.

Right to Privacy and Right to Humane Treatment. The Eighth Amendment not only protects me but allows law enforcement before torture laws to "hunt down Bonnie & Clyde, in 1934" after murdering 10 people and resisting arrest. Gun them down Constitutionally. It works both ways. Also the Fourteenth Amendment "serious procedural due process violations" and US Attorney General collusion with Judges, and Legal Fraud, Court Fraud and Fraud Upon the Courts", to evade a \$500 million dollar lawsuit. Serious Equal Protections violations to Obstruction of Justice to all the United States Court systems. Also Equal Protections Clause Bias-motivated Hate Crimes to my disability. They all may not have hated me for my disability but this Cover Up Operations case and "framing for crazy" was 100% motivated by my Turrets Syndrome and Neural-data Operations when nowhere in my FBI Files and Investigations only files during INTENSE AGENCY SURVEILLANCE FOR 17 YEARS does it mention "Turrets Syndrome" from March 2003 when this case started until January 2020 when the Neural- data started because I made a legitimate Bank Fraud claim when my ex-girlfriend stole over \$10,000 from my account using Pay Pal. I committed no crime nor did anything wrong, but when they found my Turrets Syndrome in my subconscious mind, it was the lottery for "framing for crazy". And demonstrations to everyone of "crazy" by Torturing my eyes and Visual Cortex to reach into the depths of my subconscious mind. COCKROACHES MOTHER FUCKERS, For the past 75 months, my freedom, all my human rights, my way of
life came under attack by government agencies because I have Turrets Syndrome. Nowhere between
March 2003 and January 2020, for 17 years of intense agency surveillance does it mention "Turrets
Syndrome" in my files. Until Neural-data met Turrets Syndrome and a catastrophe of discrimination. By
FBI, DOJ, President, Congress, and a series of US Attorneys, and over 15 District and United States
Supreme Court Judges. After George Floyd Hate Crimes "sentencing enhancements" for bias-motivated
hate crimes, but because I'm white and 45 year old male it's not discrimination and I'm not gay or
transgender I'm not weird enough so it's not discrimination. The agencies went from discrimination on
black people 100 years ago - George Floyd, to Disability discrimination, and Honorable Discharged
Veterans. All I can say is "go back to the Black Americans and leave me the fuck alone!! Leave us disabled
people out of your dysfunctional shit". At the time it was called "Abnormal Mental Activity". That's expected
when a person has Turrets Syndrome. It was a series of deliberate and attempting to murder me with

serious deadly acts daily for 75 months of brain concussion, gassing me with VX Nerve Agents gasses and liquids where just 10mg on the skin kills you from Cardiac Arrest when it hugs your heart and squeezes. The victims were myself, my children who suffered with no father and my sister who killed herself because I could not take care of her when my father passed away like I had promised. I could not work due to being Tortured and could not help her like I promised. I felt like I killed her myself. All our lives were ended by evil, despicable Terror and Torment. These violent attacks with Chemical Nerve Warfare daily has filled us all with disbelief, terrible sadness, and a quiet, unyielding righteous indignation that grew stronger the more I was wronged. These acts of gross violations of human rights were intended to yield me into madness and insanity daily Tormenting me and making me overdose daily on Chemical and Biological Toxic substances intended to poison me. I will have nightmares of the brain seizing and epileptic seizures in my sleep for ever from this attack to my brain and body and heart and lungs. The experimentations with my Turrets Syndrome I will have traumatic stress for the rest of my life and the evil and demented experiments to torturous levels every single day all day and all night for 75 months straight. So torturous my brain used 20% of my body oxygen at rest, they would torture my brain so badly it would run itself out of oxygen and I would go unconscious and a concussion all the time all day long. I have survived so far, nobody has ever survived 75 months of "MORE THAN LETHAL DOSES OF NERVE AGENTS EVERY 4 FUCKING HOURS" "more than lethal doses of Nerve Agents daily". That's the exact definition of daily First Degree Attempted Murder for 75 months consecutive. I am the only survivor ever known to survive Nerve Agents exposure for this long. The brain damages are extreme. The damages to my bones, muscles, cartilage, vertebrae and discs in my spinal column are eroded and demineralized. My digestion and organs suffer daily by the poisoning and have permanent damages. My hormones are completely dysfunctional for life, I am now impotent for life. And hair loss. My whole body has rotted from the inside out, where poisons are deadlier than bullets, and hurt more with excruciating internal pain and suffering. Nerve Agents are the same deadly as Anthrax, where the same amounts kill you. Extremely poisonous and venomous where one drop kills 10 men. It's a

weapon of mass destruction, used in the past to kill 1700 soldiers. I was Targeted for attack because of Abuses of Power, and extreme discrimination to my disability, a neurological nerve disorder all over my body, heart and lungs. I have experienced extreme evil, the very worse of human nature, and I have responded with lawsuits and criminal charges to those responsible for this horrific crimes against humanity. Immediately following the first lawsuit in California, retaliation from the FBI daily, and got even worse when I served Christopher Wray my Torture paperwork, in January 2025 he offered me money at first, then turned on me and ordered me to be Tortured to my death for Terrorism. My first priority is to seek help and end this madness, the FBI and DOJ are truly out of control, and get my restraining order and protect myself from these criminals from further daily attacks. I am facing corruption and conspiracy to murder me within the legal system, the weaponization of the entire legal system against me and must criminally charge all those responsible and to bring them to justice. I will make no distinction between the FBI Terrorists who committed these acts and the DOJ who harbor them. I appreciate so very much the members of Congress for standing strong behind serious human rights violations and setting up our legal systems to check on government corruption. I am joined with all those who want peace and security in America and the world. I am one man combatting Terrorism and FBI and DOJ conspiracy to murder me. My security and the security of my family has been threatened and abused for so long, I don't remember what it feels like to not be Tortured. I pray that one day I will be remedied by a power greater than any of us. God has not yet stopped my heart to save me despite daily attacks to my heart and lungs making me overdose daily on Chemical Weapons. This is a day when all Americans will unite and stand for justice and peace. To be honorable when the time arises, to be responsible with our daily lives, and be completely honest with ourselves and others, and in the best case, end the suffering of others when you can help. Greatness is not building wealth and a kingdom for yourself. The great people of our past were measured by how much they did everything for others.

STOP THE BULLSHIT CAMPAIGN. Restoration of Law and Order. Jasmine Crockett words. I require my medication immediately the FBI and DOJ are obstructing me from taking like insulin for a diabetic. We need to talk about this immediately. Obstruction of justice by weaponizing the FBI and DOJ investigators on me illegally. To evade his impeachment. Poisoning me February 2026.

IMMEDIATE MANDAMUS IMMEDIATELY REQUIRED AND MINISTERIAL. First of all, I require this court to force the FBI and DOJ Investigators to immediately respect all my Rights and Freedoms. Not a restraining order but a Mandamus immediately. To the Administration, U.S. Attorney General and the FBI Director. The ACHR, 1969 is very clearly established and my "RIGHT TO JUDICIAL PROTECTION" is very clearly texted. Also my "RIGHT TO JURIDICAL PERSONALITY". All my human rights have been taken from me by the FBI and DOJ investigations. To seize all Federal Operations without probable cause. Franks v Delaware, 1978. And Bivens, 1971. Federal Bureau of Narcotics. Warrant Clause Jurisprudence Hearing. This Supreme Court MUST RESPECT THE FEDERAL CLAUSE. Article 28. American Convention on Human Rights, 1969.

This case was supposed to have been Judicial Remedied 400 days ago but all you Judges colluding with the defendant and went stupid. The United States collusions of 5 USC 702. Administrative Procedures Act. You all fucking know better than this and you're acting fucking stupid.

EVERY FUCKING DAY DELETED.

Be ready for "brain torturing in the courtroom". I will literally tell the judges how they are torturing my brain. I will take it to the death and probably die in court. In front of the Judges. This court case means this to these immature retarded people.

The American Criminal Procedures for all these 18 US Codes is the exact same thing as the procedures of the CAT. For criminal prosecution. The Protections of the Court are the exact same as any other. Every single "Cause of Action" in the United States is a predetermined outcome by Congress. Based on Merit of the Civil or Criminal court proceeding. The Judges discretionary decisions thereafter based on

ministerial laws or discretionary laws. That's a great thing and I'm looking forward to challenging the intelligence of these U.S. Supreme Court Judges.

I'm fucking running for President of the United States in 5-10 years so fucking be ready for common fucking sense raining all over Washington DC soon. You're stupid fucking weaponization and corruption. I'm not just traumatized from it. That's the biggest fucking understatement in world history that the earth has been going around the sun like an electron. After reading about Nelson Mandela and living in South Africa 1991- 1995. We will talk about my drug history 10 years ago and 15 years ago. And compare it to Patel and Bondi. These FBI substances hit you on a cellular level and there's nothing a man can do about it, his cells acting differently and abnormally due to the nerve agents and hormonal destruction of his body, literally biological and toxic substances specifically engineered for human insanity. When I'm no longer being drugged any more from human insanity I'll have the biggest drug hangover in history and a huge re-adjustment to freedom from being drugged by agencies. To appreciate freedom like no other human in history. I was told by another messenger I was going to heaven but I'm already here, just need this mandamus to respect my human rights. We require to talk about all the elements of all the laws and an entire legal Jurisprudence of this entire case. Fourth Amendment Direct Violations, First Amendment, Fifth, Sixth, Eighth, Fourteenth.

There's no mandate to falsely accuse any American of anything whether targeting or drug targeting or terrorism, suspected terrorist, domestic terrorist or known terrorist. Nowhere does it say it's OK to falsely intentionally accuse any American. How are lawsuits not expected.

This is a Political Nightmare for me, literally being politically attacked for 400 days seriously injured. March 2025 there were 9 ambulances in 15 days, and not enough morphine in the hospitals for my pain and suffering. Morphine does nothing for Central Nervous Systems pain and attack with chemical nerve weapons. Bleeding to death from the poisoning, we will talk about all this, and I'm just trying to save my own life and give me a criminal trial please if you are going to allow them to punish me. If not then please help me to save my life. This Extrajudicial Killing is schizophrenic and psychopathy. I am literally being falsely accused of imaginary terrorism and committing imaginary crimes and the FBI and DOJ are saving 5000 imaginary Americans from me every day by Torturing me to my death (not imaginary). And there's delusional Schizophrenia in this with persecutory delusions of Terrorism, the psychosis that haunts them and then they believe I am going to hurt people so they act on their delusions now. Narcissistic rage happens when they start acting on delusions towards my disability and using chemical weapons and they have absolutely no insight on their sickness of disturbing psychopathy and then can't tell the difference between their delirium or schizophrenic behavior. "Psychotic schizophrenics with weapons" injuring

innocent Americans. Calling innocent Americans “terrorists” to attack them on purpose. Then they are surprised when lawsuits come and “kill the innocent American” now.

“Targeting” and “Drug Targeting” is just a work creation program. And once it gets to the court level it’s finished. Because no crack head seeks help from US Supreme Court. Maybe try not attacking people that know everything about their operations next time. We will talk in detail about this work creation program and “hate lists” allowing federal and government to add whoever they want for hate crimes.

American law is clear and very well established. What’s wrong with all you people that think you can just do whatever the fuck you want. Yes you have ideas, save that for your own lives and don’t impose them on others. If everyone agrees with your opinions on who should selectively get deported. How would you feel if that was you. Take your schizophrenic ideas and share them with your mental health friends not the country because you just look stupid to everyone.

This Court is already bound to the American Disability Act, 1990. Wheelchair access and must adhere to my case. This is an enforcement to cater to the disabled and an absolute prevention of any sort of discrimination and especially bias-motivated hate crimes and serious injuries.

There’s no genuine issue of material fact for judicial remedy in this case. Just an absolute rejection of accountability by the United States and Trump. Forcing all these criminal charges after 400 days in the US Supreme Court. This case should have been settled 400 days ago. Trump is just a piece of shit treating me like he abuses women in the Hawaii District Court Rape Lawsuit. Where I found out that Facebook Messages, Text Messages and Emails are 100% admissible in Court. Also the Stress Cardiomyopathy case of the 22 year old virgin on YouTube where her boyfriend lied and said he’s a virgin too. She sued for broken heart and won her case. It’s a 23 minute case. With text messages saying “I’ve had better”. The female Judge went off her reservation on that one.

This case I'm like a seriously abused wife trying to get divorced from extreme abuses. Extremely abusing husband and non cooperative. Please help me. This experience is literally reliving the same nightmares over and over again everyday all the time.

I have studied the Watergate Scandal and this Trump case makes the Watergate Scandal look like Mickey Mouse. I tried to make a 28 USC 509B complaint to the DOJ Human Rights Criminal Division but Bondi Obstruction of Justice. Evasion of Criminal Charges. Tried to make a OSC Compliant and Patel Obstruction of Justice and Evasion of Criminal Charges. Tried to make a DOJ Office of Inspector General Complaint on Bondi but she Obstructed me. Tried to make a OSC Complaint but Bondi Obstruction of Justice.

The real reason why this neural-data case started must be investigated in December 25, 2019-February 15, 2020. This Supreme Court must know the truth about this case. Internal Affairs of the Mayor Office I believe are investigating this case currently.

This US Supreme Court MUST SERVE ALL DEFENDANTS IN THIS CASE pursuant to Federal Rule of Civil Procedure 4 (C)(3). I will provide a list of defendants. All of Trump Administration, U.S. Attorney General, FBI Director, all of Oversight and Judiciary Committees and all of Congress. For Trump Impeachment.

The Trump Administration, U.S. Attorney General and FBI Director has demonstrated absolute lawlessness and the epitome of lawlessness in this case, the immigration operations and the purges case. Literally legal fraud , court fraud, and fraud upon the courts for \$18, 370,501,250,000. Instead of fighting this amount in a court of law District Court of the Virgin Islands, St Croix. And \$500 million dollars in the Eastern District of California. And the weaponization of their Federal Agencies to conduct absolute lawlessness. Maybe next time don't order them to conduct absolute lawlessness. They could have also

told the Judges to give me less money if they had a problem with the money. That's discretionary with the Judges. Literally turned Federal Operations into trailer park across the Nation. Orchestrated and intentionally Created violence and 14 deaths and the sickest most disturbing Torture case in American History. The criminal liability for those 14 deaths being Bondi. And the Torture case was a premeditated intentional joined effort of the Criminal Defendants. Miranda v Arizona 1966 is respected Nationally for a reason and detainment warrants. There's nothing wrong with the sovereign immunity of the executive orders for immigration and ending weaponization of January 20, 2025. It's the direct violations of the discretionary function exemption to both those executive orders that caused the 14 deaths, the purges and my Torture case/ Attempted Murder/ Conspiracy to Murder case. See video of Ryan Schwank. See video of Turrets Girl. See video of Good Will Hunting.

The FBI and DOJ are attacking my faith in god. And that I'm 45, white male and that I am of poverty status. I require Equal Protections against Donald Trump money. His President Qualified Immunity and Powers are the exact same as any other federal employee and his discretionary powers. Presidential Sovereign Immunity changes and applies to their executive orders and laws, and the Bush CIA Enhanced Interrogation Memo of 2001 is the perfect example of this. We will talk about this one in our hearing. The discretionary decisions limitations are the exact same as any other Federal Employee. This falls within the Discretionary Function Exemption, 28 USC 2680a. The President is just another Federal Employee that works for the American People. He does not own us.

I require this stupid operation to stop immediately without any legal and legitimate warrants. I don't require a restraining order but require Judicial Protection from Federal Operations falsely accusing me and murdering me with Hybrid warfare neural-data operations and Chemical Nerve Warfare definition in the chemical Weapons Convention. This must be stopped immediately it's a public safety matter of life or death. If this court wants to punish me for the 15 year old girl then criminally charge me please. And a

criminal trial. Please stop this Extrajudicial Torturing just for getting a 15 year old drunk and fucking her. This FBI and DOJ Investigations hatred must be stopped PLEASE SAVE MY LIFE!!! This type of hatred of the FBI and DOJ Investigations happened to Trump in 2023 for fucking Katie Johnson at 13 years old and a few more young girls. The they criminally charged him with 91 criminal charges in 2023. There's nothing to criminally charge me with so they are Extrajudicial Killing me instead. I admit that Katie Johnson was better looking than my 15 year old girl. This retaliation of the FBI and DOJ investigators led to the "PURGES" retaliation of Donald Trump. This neural-data technology is too powerful to be irresponsible with. There must be responsibility enforced for the use of neural-data technology. It's 1000X worse punishment than any humane jail. They are torturing my disability and sexually assaulting me for this matter. Motivated by my disability to torture my neurological disability. Literally a \$44,000 per day Federal Operations to Sexually Torture me to death.

There must be an impartial investigation immediately into this case. CAT Article 13. Internal affairs or in this case the DOJ Office of Inspector General that was started for the Watergate Scandal and U.S. Attorney General John Mitchell and resignation of Nixon. Officers of Inspector General Act, 1978. Or in this case might be better HPCSI Congress investigating this case. They are much better at Conspiracies especially with Trump, Bondi, Patel, and Wray. I don't deserve the death penalty without any criminal trial. Every day in February 2026 has been Attempted Extrajudicial Killings, Federal Operations ordered by Trump, Bondi and Patel. Chemical Nerve Warfare Death. And Sexual Assaulting me every single day and night, sleep deprivation and no sleeping whatsoever since November 2025.

Then they have orchestrated a list of 150 false accusations because of this to murder me. They have spent over \$100 million dollars spitting on tax payers to make me suffer and pain for

this sex problem. Psychological and Mental Torturing. They can't just do whatever they want, they need to follow Criminal Procedures Act. Administrative Procedures Act. And DHS procedures as well. 1

Donald Trump calls me a child rapist when he is too. And then hates me for suing the USA for neural-data then he sued the USA for neural-data. Then he calls me a terrorist and adds me to internal lists falsely accusing me behind my back when he is committing domestic terrorism. According to the DHS Act 6 USC 101-(18) and 18 USC 113B sec 2331. This is a 100% personal case between me and Donald Trump. 2

The psychological torture and mental torture is 1000X more traumatic than any pain in the world. The psychological torture and trauma of being 100% falsely accused. Drives a person insane especially my circumstances being falsely accused behind my back like this. That's what this entire case is since the beginning. Not just no due process rights but no human rights whatsoever since the beginning of this case. All of the ACHR, 1969. All of it including mental slavery which we will talk about. Substantive Due Process Claim. That falls within the Civil Rights Act, 1871. And 1964. Electrical frequencies to target the brain 24/7 even when trying to sleep. And cranking the voltages from the chemical weapons in my eye sockets. Eye Torturing and visual cortex torturing 24/7. While I cry about the sick and disturbing pain all day every single day and they do it more and stronger the more I begging to stop. This is all for the creation of insanity to demonstrations and videos for showings of "CRAZY" to win lawsuits behind my back to all the judges as I am being utterly raped and demented brain tortured and demonstrations of 18 USC 2340 to all of Congress and all Judges. 100% falsely accused me of "crazy" when the most disturbing and demented torturing happening in American history. After Donald Trump 8 months of neural-data operations and 91 criminal charges. He still sued for there not being warrants for neural-data and being illegal.
