The Petitioner, Lisa Ann Dewese respectfully prays that a writ of certiorari be issued to review the judgment below.

**OPINION BELOW**

The Order of United States Court of Appeals, Federal Circuit which appears at Appendix A to the petition and is reported at GovINFO, Justia, PacerMonitor and CASEMINE.

**JURISDICTION**

The date on which the United States Court of Appeals for the Federal Circuit decided the matter was March 20<sup>th</sup>, 2026 and no petition for rehearing was filed in the case by either party.

The jurisdiction of this Court is invoked under 28 U. S. C. § 1257(a).

### STATEMENT OF THE CASE

Plaintiff, Lisa Ann Deweese is representing the US government, herself and a class of similarly situated individuals, acting as relator and Vox Populi.

The CPS agents file abuse/neglect petitions in a Court of law without a claim against parents, state that those petitions are served upon the parents, however those petitions do not served upon the protected person(s) as claimed by the CPS agents. The protected person(s) involved in a state custody case are denied due process. The protected person(s) cannot enter a plea of "not guilty" and/or demand trial to deny the charges. Parent(s) are not even allowed to change their plea from "no contest" to "not guilty". In fact, they are coerced into taking a plea of "no contest". It's guilty as charged.

Real child abuse and neglect cases are heard in a District Court's Criminal Division and the parents are allowed to plead no guilty, request trial to deny the charges and may even face incarceration for the crime if proven guilty.

The CPS agents falsely claim that the parent(s) agree to the terms and conditions of the mediation contracts and the safety plans. However, the parent(s) do not waive their right to trial, agree that the CPS can keep their child(ren) for up to two years, agree that the CPS can terminate their parental rights nor agree that the CPS can place their child(ren) up for adoption.

The mediation contracts are read out loud to the parent(s) by the CPS agents. Parent(s) are not given a copy of the documents so they can read along. The

contracts are not read word for word. Many CPS documents get lost, stolen or misplaced. CPS policies allow for the destruction of court documents and may be a reason why parent(s) cannot always obtain copies of the record proper.

Family centered cases lack Court oversight. These "Hidden or Shadow" cases do not include any kind of Court action what so ever. The parent(s) are not given the usual court awarded counsel, the children do not have counsel, the families never appear before the Court. All matters in the case are decided by the CPS agents. Children are not allowed to testify in any type of CPS case.

The CPS agents abuse and misuse the police in order to enforce the children's code. The people believe that they could be put to better use fighting real crimes.

Parents have claimed that the CPS agents took their newborn from them at the hospital, never opened a case against them and never returned their baby.

CPS agents fail to report foster kids missing from state custody to anyone. CPS agents pick children up from off the street and keep them in state custody without informing their parents. When a child dies in foster care it is covered up. Children in state custody are not allowed to attend the funerals of their family members.

The CPS agents make promises to the parent(s) that they do not intend to keep in order to get the parent(s) to sign reports on mediation. The parent(s) expect their child(ren) to be returned to them after signing the contracts, but instead are given a long list of tasks that must be completed called the "treatment plan". This sets the parent(s) up for failure. CPS agents use many crazy excuses to terminate parental rights. Parent(s) are expected to work full time jobs and complete a long list of

stupid human tricks. This causes the parent(s) to lose their job, vehicle and to become homeless and the CPS agents use this as an excuse to keep the child in state custody and/or terminate parental rights.

The CPS agents force child(ren) in state custody to take mind- and mood-altering drugs against the wishes of the family. Many former foster kids report being raped, sodomized, pimped out, impregnated by the foster dad and have had their children sold in the baby black market. Some former foster kids claim that they have had organs harvested from them by the foster parents. There have been claims by former foster kids that they were made to take part in Satanic rituals.

The CPS agents claim that the parent(s) are poor, mentally ill, alcoholic, crack whores with violent tendencies and these are the grounds for state custody of the child. The CPS agents act as if parents are paypigs and their children are cash cows and this is reason for the Civil unrest in the USA.

The Indian Child Welfare Act is being violated by the CPS agency and this has many Native American community members angry, hurt and confused.

The Child Protective Service's agents conduct unlawful searches and seizures. They enter homes without search warrants, take personal property that does not belong to them, kidnap the children living in these homes and place them in nondisclosed locations, causing them to become beyond the protection of the law and expect a reward for this.

## **REASONS FOR GRANTING THE PETITION**

Every person who, under color of any statute, ordinance, regulation, custom, or usage, of any State or Territory or the District of Columbia, subjects, or causes to be subjected, any citizen of the United States or other person within the jurisdiction thereof to the deprivation of any rights, privileges, or immunities secured by the Constitution and laws, shall be liable to the party injured in an action at law, suit in equity, or other proper proceeding for redress, except that in any action brought against a judicial officer for an act or omission taken in such officer's judicial capacity, injunctive relief shall not be granted unless a declaratory decree was violated or declaratory relief was unavailable. For the purposes of this section, any Act of Congress applicable exclusively to the District of Columbia shall be considered to be a statute of the District of Columbia.

Adequate, effective and prompt reparations to promote justice by redressing gross violations of human rights laws and/or serious violations of humanitarian laws to repair the harm caused by the US and acknowledge the consequences of the violation by the US against the victims of the CPS should be this Nation's number one priority. Another reason to grant this petition is to prevent and eliminate Human trafficking by the US Government. Granting this petition is the only real way to save this Nation from economic collapse.

Continued funding for the CPS agencies is a criminal activity and contrary to The International Convention for the Protection of All Persons from Enforced

Disappearance (ICPPED) even though the US has not signed or ratified the treaty. Funding for the C.P.S. has bankrupted this County and is reason for the 39 trillion-dollar nation debt. Continued funding for the CPS should be viewed as a crime against humanity.

Furthermore, funding for the CPS violates The Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (commonly known as the United Nations Convention Against Torture (UNCAT)). The People have been demanding freedom from CPS torture or cruel, inhuman or degrading treatment or punishment for over sixty decades but their pleas, prayers, petitions and complaints have fallen on deaf ears.

Without checks and balances, a majority faction would oppress minority groups, contradicting the ideal of equality enshrined in the Declaration of Independence. When citizens perceive the government as not upholding the founding principles, it leads to decreased faith in institutions and potential political instability. The US is often viewed as a model for democracy globally, and failing to live up to its founding ideals could undermine its moral authority on the world stage. The people feel as though the government has been waging war against the family.

The Child Protective Services are viewed by the people as a threat to their family's happiness and insist that they be abolished. Families belong together. A happy family makes the nation strong. The family unite is torn apart by the collective and collaborative actions of the CPS and this makes the country weak.

When families are healthy, supported, and well-functioning, they contribute to a stable and thriving society at large, as families are considered the foundational unit of any nation, shaping individuals' values, ethics, and overall well-being from a young age is the parent's primary role, not that of the governments. The C.P.S. has taken over the role of the parent and destroys the family unit. The true target of CPS agents is not suspected child abuse and neglect, but the funds in the State Treasury.

There is a constitutional clash over control of taxpayer money. The people do not want to fund the part of the Government that is targeting poor families and could be the reason so many Americans refuse to work. On the other hand, the CPS agents maintain that they have many problems and that more money is needed in order to fix them. The Petitioner asserts that no funding for the CPS would actually fix all of their problems.

The citizens of the US are tortured by the Totalitarian regime of the CPS and have been complaining about the policy practices of this government agency since its beginning. The right to respect for private and family life is violated by the CPS.

A statement closely associated by President James Monroe which suggests that "unless the nation adhere to the principles set forth by our founding fathers this nation will be invaded by foreign soil", is as true today as it was in 1823.

Happy families tend to foster positive values like responsibility, empathy, and cooperation in their children, which can translate into a more productive and

cohesive community. The CPS agency is counterproductive to a strong nation and their agents are seen as strangers, which leads to instant mistrust.

Strong family units provide a sense of belonging and security, which can lead to lower crime rates and improved mental health within a population.

Families play a crucial role in early childhood development, providing essential learning and support that sets children up for success in life

Strong family bonds can help individuals cope with challenges and bounce back from difficult situations, contributing to a more resilient society.

Families cannot be happy while being torn apart. If the US does not adhere to the principles established by our Founding Fathers, it would potentially lead to a loss of individual liberties, a decline in democratic values, increased societal unrest, and a weakening of the nation's legitimacy, as the core values of equality, freedom, and limited government that the Founders enshrined could be eroded over time.

The core principles of the US, like freedom of speech, religion, and the press, are compromised when the government deviates significantly from the Founders' vision of individual civil liberties. We need to do the right thing here.

Public schools in the US have classes on parenting set up in the curriculum and which makes the imagined need for the CPS obsolete.

## CONCLUSION

The petition for a writ of certiorari and any other relief deemed fit, prudent and appropriated by this Court should be granted.
