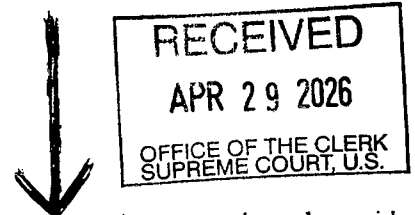
At a Court of General Sessions, convened on **MAR 18 2025** the Grand Jurors of Greenville
County present upon their oath:

COUNT 1 - MURDER

That ~~PHILLIP CHARLES REEVES~~ did in Greenville County, on or about the 18th day of September, 2024,
unlawfully and with malice aforethought kill ~~MINDY MCDONALD~~ by means of shooting her in the neck, and
that ~~MINDY MCDONALD~~ died as a proximate result thereof. This is in violation of §16-03-0010 of the South
Carolina Code of Laws (1976) as amended.

COUNT 2 – POSSESSION OF A WEAPON DURING THE COMMISSION OF A VIOLENT CRIME

That ~~PHILLIP CHARLES REEVES~~ did in Greenville County, on or about the 18th day of September, 2024,
possess or visibly display a handgun during the commission or attempted commission of a violent crime, to wit:
~~MURDER~~. This is in violation of §16-23-0490 of the South Carolina Code of Laws (1976) as amended.



Against the peace and dignity of the State, and contrary to the statute in such case made and provided.

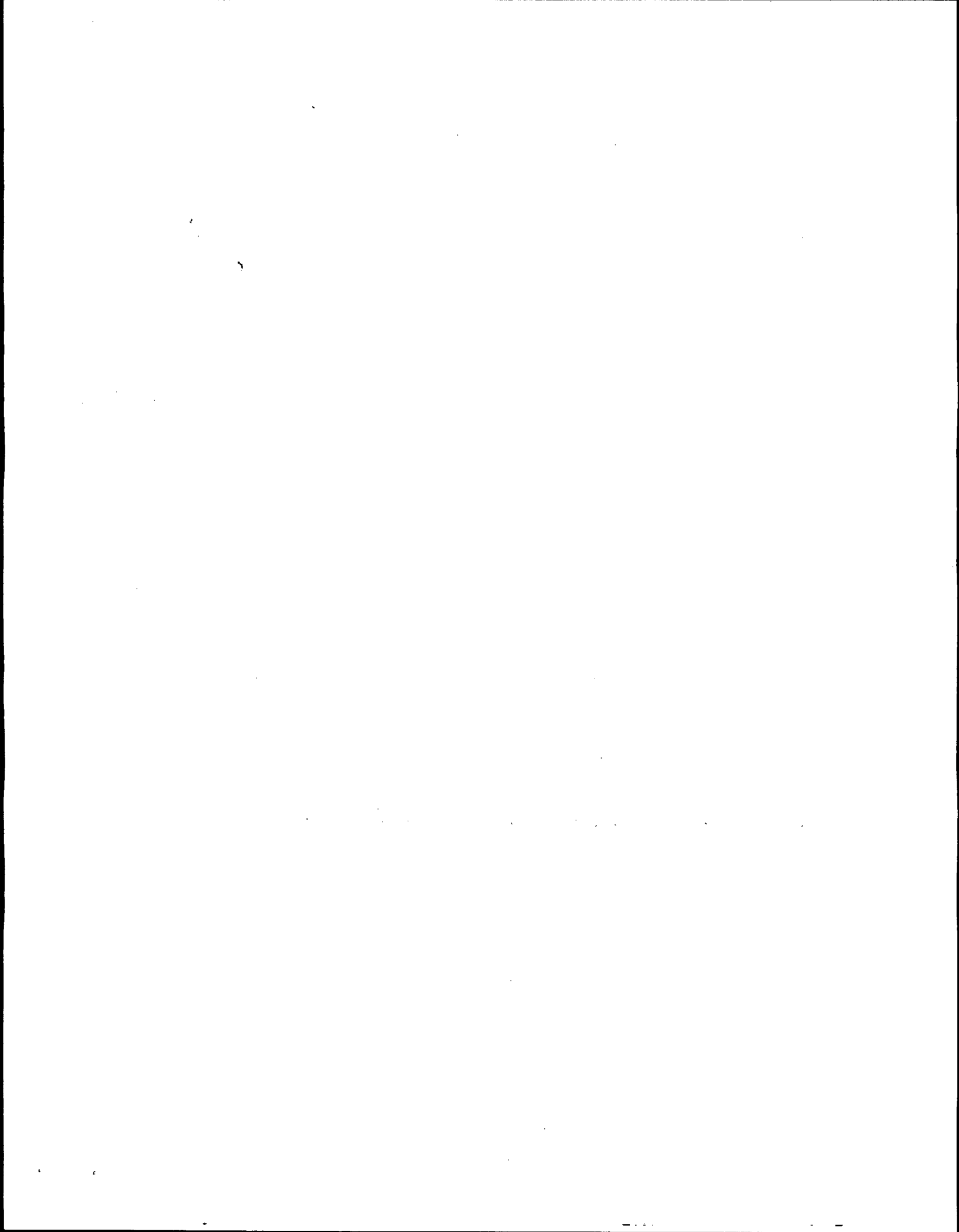

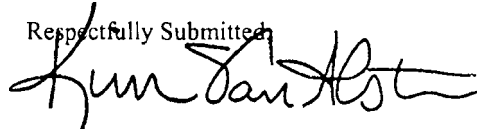

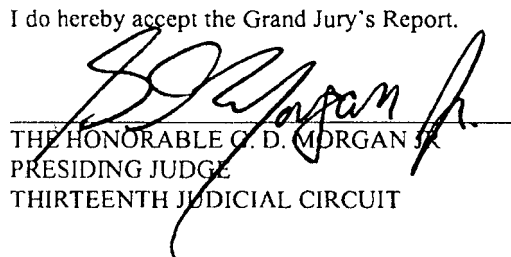
