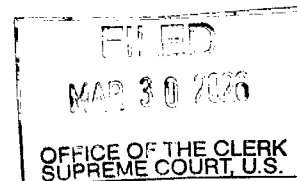

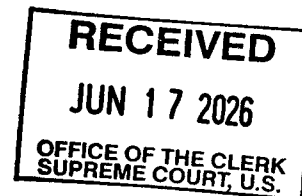

MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

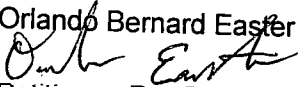
I, Orlando Bernard Easter, respectfully move this Court for leave to proceed in forma pauperis pursuant to Rule 39 of the Rules of this Court.

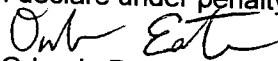
