I write on behalf of the Respondents Bette Eakin, DSCC, DCCC, and AFT Pennsylvania (“Eakin Respondents”) in the above-referenced cases, in which petitions for a writ of certiorari were filed on February 11, 2026, and placed on the docket on February 13 and 17, 2026, respectively. On March 19, 2026, Eakin Respondents waived their responses to the petitions. On April 1, 2026, the Court requested responses by May 1, 2026.
