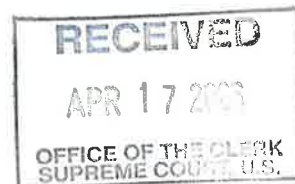

APPLICATION TO EXTEND THE TIME TO FILE A WRIT OF CERTIORARI TO  
THE UNITED STATES SUPREME COURT

Procedural History and Nature of Case

2 Plaintiff Johanna Delgado, has had a very unfortunate life. Like in all things, there are good and there are  
3 bad, unfortunately, the bad outweighs the good and a pattern of corruption, of fraud, of deceit, and  
4 conspiracies was evidenced and proven beyond reasonable doubt, perpetrated on plaintiff Johanna  
5 Delgado by both state and Federal government, wrongdoings dating back to when plaintiff was a child  
6 which continued throughout her life while oppressing plaintiff and depriving plaintiff of justice, of redress  
7 and of due process, inter alia. A criminal conspiracy was also plotted for several decades of petitioner's life  
8 which the conspiracy was between the California and United States Government alongside other Nations  
9 including but not limited to China and Mexico. This conspiracy against the United States of America and  
10 Petitioner Johanna Delgado also includes the various Nations alongside the Media of said Nations and  
11 internet broadcastings, to traffic Petitioner for years if not decades of Petitioner's life without the knowledge  
12 and or consent of petitioner. This also took place post petitioner having her daughter Elisabeth Joy Sibillo  
13 on February 10, 2014. The trafficking got worse and with aid of many for decades as Petitioner has made  
14 the case and proving all beyond reasonable doubt, which triggered the clause known as "Preamble", within  
15 the foundational document; "In Congress July 4, 1776. The Unanimous Declaration of the Thirteen United  
16 States of America." Also known as the Declaration of Independence. When plaintiff applied this clause post  
17 years of studying, as the clause allows Petitioner per her right, her duty, per the authority vested in her, she  
18 legally overthrew her tyrannical government and made Treason cases, criminal cases against the same  
19 while also forming a new government and new guards for the Nation, amended the United States  
20 Constitution and all which needed to be addressed to ensure the future happiness and safety of petitioner  
21 as is allowed given the aforementioned clause. This foundational document to the United States of  
22 America is the most important of them all for it is the contract and sole document which made the United  
23 States of America a sovereign country no longer under the British Monarchy rule, pursuant to rule 902. In

and federal courts are torturing plaintiff, experimenting on plaintiff without plaintiff's knowledge and or  
consent, they are libeling plaintiff, degrading plaintiff, having law enforcement do the same while also  
sexually harassing plaintiff and assaulting plaintiff. Plaintiff has also been raped by law enforcement the  
first time plaintiff was 15 years old, and it happened again on or around 2017. Plaintiff made a police report  
and complaint given the second rape which was perpetrated by a Riverside County Sheriff's Department  
Deputy, and spoke to a detective named Amy Contreras. Prior to this and as a result to this, the whole  
Riverside County deprived plaintiff of life itself and all of plaintiff's rights, trafficking plaintiff on an  
international scale. To this day plaintiff is deprived of her privacy even in her home, in the bathroom at all  
places and at all times, also her proprietary vehicles. Plaintiff has also been told by many of the witnesses  
which are from most if not all places of the world, including but not limited to Mexico, South America,  
Europe, Asia, Middle East, Africa, all over how she is being streamed and what petitioner does and or did,  
many times harassing plaintiff and sexually harassing. This resulted in the COVID19 Pandemic which is a  
Plandemic proving how all has been done on purpose to destroy our collective economies and overthrow  
our United States constitution which those in authority doing so, by imposing all of these tyrannies are  
levying war on the United States Constitution, which unequivocally constitutes treason to the United States

of America. Financed and pushed by the world terrorists mainly those in the technology sector and artificial intelligence in order to enslave all people as has been done to plaintiff with technology and mass surveillance, an evolution of the Holocaust, all repugnant to the Constitution. This is also financed by the most prominent and all banks, hedge funds, multinationals therefore, they are equally liable for the war crimes, crimes against humanity, for the numerous felony offenses which get ignored and bypassed by our bribed and compromised law enforcement and judicial branches, which are including but not limited to conspiracy against rights 18 U.S.C. § 241, deprivation of rights within colors of law 18 U.S.C. § 242, it is frauds and swindles 18 U.S.C. § 1341, depriving people of their intangible right to honest services, which is also fraud 18 U.S.C. § 1346, as plaintiff has proven beyond reasonable doubt with this case, all of which are felony offenses and this without getting into the international crimes of terrorism, war crimes, crimes against humanity repugnant to all in existence which prohibits these barbarities in the United States of America and Internationally as plaintiff has also made the case and proven beyond reasonable doubt. Pursuant to rule 902 in the Hitler, Nazi Era, the satanic eugenicist Nazi's put tattoos on the Jewish people, which at the time the Jews were known for having money, making the middle class to the elite class as a result. All was stolen from them and they were deprived of all of their rights and this tattoo was a form of tracking all Jewish people to then experiment on them, enslave them, compel them to involuntary servitude, to torture them, to enslave all of them, following their getting massacred pursuant to rule 902. A 2016 report found that fewer than one-third of data center operators track water consumption. Water consumption is expected to continue increasing as data centers grow in number, size, and complexity. According to scientists at the University of California, Riverside, each 100-word AI prompt is estimated to use roughly one bottle of water (or 519 milliliters). This may not sound like much, but billions of AI users worldwide enter prompts into systems like ChatGPT every minute. Large language models require many energy-intensive calculations, necessitating liquid cooling systems." Nothing validates and or makes ok the use of these data centers, technology is taking over human life while those at charge deliberately and publicly plot to abolish human rights and human dignity, to completely take over and or exterminate humans. There are still big gaps in our understanding of the impacts of data centers, even as they boom in number, said Andrea Marinoni, associate professor with the Earth Observation group at the University of Cambridge, and an author of the study, which has not yet been peer-reviewed. Marinoni and his colleagues decided to dig into one under-researched impact: the heat they release through their energy-intensive processes, including computation and powering cooling systems." The findings also found that when the datacenter becomes operational there is a temperature increase by an average of 3.6 degrees Fahrenheit, with extreme case temperature increase by up to 16.4 degrees Fahrenheit. These findings were consistent around the world and in Mexico alone, said data dates back 20 years. Further, said temperature increases also affect surrounding areas up to 6.2 miles away. Using the same tactics of which also Charles Kushner utilizes for spying, these mass surveillance occult, hidden cameras depriving any and all of their privacy, and taking over the inventions, know how, discoveries of the victim, these prominent entities have been taking over the world and the lives of any and all they target. 22 Former escort to the elite turned First Lady Melania Trump will be using this \$70 million private jet for her  
23 own use. This fraud to claim this jet was for deportations, turned to a personal jet for Melania Trump and  
others within the administration. These embezzlements are out of control, not justified and cannot remain  
unpunished and or unaddressed within our DOJ, but they do nothing because they are a criminal mafia.  
Further, by trafficking me, they are also in violation of inter alia 18 U.S. Code § 552 - Officers aiding  
importation of obscene or treasonous books and articles, yet the FBI and DHS do nothing about these  
mounting crimes despite being advised numerous times by plaintiff for they too are trafficking plaintiff.  
This because we have a two tier justice system which oppresses the working class and favors the  
academic creed elite, part of and at the top of these brotherhoods, associations, creeds, cults and or  
gangs. This is how and why the current administration has some tyrannical entities in the United States

14 follows; "The Legislature hereby declares that advances in science and technology have led to the

16 communications and that the invasion of privacy resulting from the continual and increasing use of such  
17 devices and techniques has created a serious threat to the free exercise of personal liberties and cannot  
18 be tolerated in a free and civilized society. The Legislature by this chapter intends to protect the right of  
19 privacy of the people of this state. The Legislature recognizes that law enforcement agencies have a  
20 legitimate need to employ modern listening devices and techniques in the investigation of criminal  
21 conduct and the apprehension of lawbreakers. Therefore, it is not the intent of the Legislature to place  
22 greater restraints on the use of listening devices and techniques by law enforcement agencies than  
23 existed prior to the effective date of this chapter." The state repugnant to the Fourth and Fourteenth  
amendment allow law enforcement to deprive citizens of their privacy. And repugnant to what is claimed  
they allow corporations to do the same. These laws create loopholes, yet the legislatures and governor  
never had the constitutional authority to do so. And like in California all states do the same, to compel all  
citizens to digital payments is depriving citizens of their rights within colors of law, is depriving citizens of  
their intangible right to honest services, and depriving of our privacy, the government and or corporations  
cannot control and monitor the spending habits of people while knowing their whereabouts at all times by  
compelling to paying with cards, credit cards and or bank cards and or digital wallets, this is repugnant to

The law reads as follows; “(a) Each county is hereby authorized to establish in each county treasury a Community Corrections Performance Incentives Fund (CCPIF), to receive all amounts allocated to that county for purposes of implementing this chapter. (b) Notwithstanding any other law, in any fiscal year for which a county receives moneys to be expended for the implementation of this chapter, the moneys, including any interest, shall be made available to the CPO of that county, within 30 days of the deposit of those moneys into the fund, for the implementation of the community corrections program authorized by this chapter. (1) The community corrections program shall be developed and implemented by probation and advised by a local Community Corrections Partnership. (2) The local Community Corrections Partnership shall be chaired by the CPO and comprised of the following membership: (A) The presiding judge of the superior court, or his or her designee. (B) A county supervisor or the chief administrative officer for the county or a designee of the board of supervisors. (C) The district attorney. (D) The public defender. (E) The sheriff. (F) A chief of police. (G) The head of the county department of social services. (H) The head of the county department of mental health. (I) The head of the county department of employment. (J) The head of the county alcohol and substance abuse programs. (K) The head of the county office of education. (L) A representative from a community-based organization with experience in successfully providing rehabilitative services to persons who have been convicted of a criminal offense. (M) An individual who represents the interests of victims. (3) Funds allocated to probation pursuant to this act shall be used to provide supervision and rehabilitative services for adult felony offenders subject to local supervision, and shall be spent on evidence-based community corrections practices and programs, as defined in subdivision (d) of Section 1229, which may include, but are not limited to, the following: (A) Implementing and expanding evidence-based risk and needs assessments. (B) Implementing and expanding intermediate sanctions that include, but are not limited to, electronic monitoring, mandatory community service, home detention, day reporting, restorative justice programs, work furlough programs, and incarceration in county jail for up to 90 days. (C) Providing more intensive local supervision. (D) Expanding the availability of evidence-based rehabilitation programs including, but not limited to, drug and alcohol treatment, mental health treatment, anger management, cognitive behavior programs, and job training and employment services. (E) Evaluating the effectiveness of rehabilitation and supervision programs and ensuring program fidelity. (4) Notwithstanding any other law, the CPO shall have discretion to spend funds on any of the above practices and programs consistent with this act but, at a minimum, shall devote at least 5 percent of all funding received to evaluate the effectiveness of those programs and practices implemented with the funds provided pursuant to this chapter. A CPO may petition the Judicial Council to have this restriction waived, and the Judicial Council shall have the authority to grant such a petition, if the CPO can demonstrate that the department is already devoting sufficient funds to the evaluation of these programs and practices. (5) Each probation department receiving funds under this chapter shall maintain a complete and accurate accounting of all funds received pursuant to this chapter.”: These funds has allowed these terrorist Nazi's to replicate mafia on a county level legalizing bribes through the same which is controlled by all of the arms of these mafia's placed in the position of authority, which is why most if not all in said positions make a lot of money, this is why and part of how Donald Trump loyalist, which has been in business with my ex husband Agostino Sibillo to my knowledge for over a decade, Sheriff Chad Bianco now finds himself making more money than the President of the United States of America as plaintiff has proven beyond reasonable doubt with facts and links which show his actual pay, pursuant to rule 902, and all of these moneys and appropriations are done on a state level and federal


1 witness and provide all of his knowledge and findings for the pending cases of fraud and crimes against
