**SECOND MOTION FOR EXTENSION OF TIME
TO PAY DOCKETING FEE AND FILE PETITION
IN COMPLIANCE WITH RULE 33.1**

1.

2.

Since the Court granted the prior extension, Petitioner has continued efforts to convert the petition from in forma pauperis format into Rule 33.1 booklet format,

organize and finalize appendix materials, and coordinate professional printing and binding services necessary for filing.

3.

Petitioner is proceeding pro se and has encountered additional delays associated with securing the funds necessary for the Rule 38(a) docketing fee, printing costs, binding costs, and mailing expenses required for compliance with this Court's rules.

4.

Petitioner has also been coordinating with appellate printing and formatting services to ensure that the petition and appendix comply with all applicable requirements of Rule 33.1 and the Rules of this Court. Additional time is necessary to finalize these materials and avoid submission of a defective filing.

5.

This request is made in good faith and not for purposes of delay. Petitioner respectfully submits that the requested extension will allow sufficient time to complete the petition in proper form and ensure full compliance with the Rules of this Court.

WHEREFORE, Petitioner respectfully requests that this Court grant an additional extension of time of thirty (30) days, up to and including July 10, 2026, within which to pay the docketing fee required by Rule 38(a) and file a petition in **compliance with Rule 33.1.**
